ANNOUNCEMENT OF FINAL DECISION TO ISSUE A CLEAN AIR ACT PREVENTION OF SIGNIFICANT DETERIORATION PERMIT THAT REGULATES GREENHOUSE GAS EMISSIONS PERMIT APPLICATION NO. PSD-TX-1012-GHG

On August 6, 2014, the United States Environmental Protection Agency, Region 6 (EPA) provided notice of, and requested public comment on, EPA's proposal to issue a Prevention of Significant Deterioration (PSD) major permit authorizing the construction of a new natural gas fired combined cycle electric generating unit Project) to the City of Austin dba Austin Energy, at the Sand Hill Energy Center in Travis County, Texas. EPA's final decision grants approval, in accordance with the PSD regulations (40 CFR 52.21), to the City of Austin dba Austin Energy to construct the Project capable of producing up to an additional 222 MW of electrical power. EPA received one written comment from the permittee concerning the draft permit during the comment period, and did not receive any written requests for a public hearing.
