

KM Liquids Terminals, LLC Condensate Splitter Plant, Galena Park Terminal Prevention of Significant Deterioration Permit for Greenhouse Gas Emissions PSD-TX-101199-GHG

Summary of Revisions in Final Permit

U.S. Environmental Protection Agency May 15, 2013

Summary of the Formal Public Participation Process

The U.S. Environmental Protection Agency, Region 6 (EPA) proposed to issue a Prevention of Significant Deterioration (PSD) permit to the KM Liquids Terminals, LLC, Galena Park Terminal on April 3, 2013. The public comment period on the draft permit began April 3, 2013 and closed on May 3, 2013. EPA announced the public comment period through a public notice published in *The Houston Chronicle* on April 3, 2013 and on Region 6's website. EPA also notified agencies and municipalities on March 29, 2013 in accordance with 40 CFR Part 124.

The Administrative Record for the draft permit was made available at EPA Region 6's office. EPA also made the draft permit, Statement of Basis and other supporting documentation available on Region 6's website, and available for viewing at the Galena Park Branch Library in Galena Park, TX.

EPA's public notice for the draft permit also provided the public with notice of the public hearing. The public notice stated that "Any request for a public hearing must be received by the EPA either by email or mail by April 29, 2013, and must state the nature of the issues proposed to be raised in the hearing...*EPA maintains the right to cancel a public hearing if no request for a public hearing is received by April 29, 2013, or the EPA determines that there is not a significant interest. <u>If the public hearing is cancelled</u>, notification of the cancellation will be posted by May 1, 2013 on the EPA's Website <u>http://yosemite.epa.gov/r6/Apermit.nsf/AirP</u>. Individuals may also call the EPA at the contact number listed above to determine if the public hearing has been cancelled." EPA did not receive any written requests for a public hearing. EPA posted its announcement that there would not be a hearing on May 1, 2013.*

Revisions in Final Permit

The following is a list of administrative and clarifying changes for the KM Liquids LLC, Condensate Splitter Plant, Galena Park Terminal (PSD-TX-101199-GHG) Prevention of Significant Deterioration Permit, Final Permit Conditions.

1. Cover Sheet

The cover sheet titled "Prevention of Significant Deterioration Permit for Greenhouse Gas Emissions Issued Pursuant to the Requirements at 40 CFR §52.21" has been modified to state the following:

In accordance with 40 CFR §124.15(b)(3), this PSD Permit becomes effective 30 days after the service of notice of this final decision unless review is requested on the permit pursuant to 40 CFR §124.19 immediately upon issuance of this final decision.

This administrative change is made as a result of not receiving any comments during the comment period related to this action.

The signature line has been changed from David F. Garcia, Acting Director to Wren Stenger, Director.

This administrative change is made as a result of a personnel change.

2. Page 16

Section V. titled "Initial Performance Testing Requirements" has been modified as follows:

 \underline{K} . \underline{L} . The owner or operator shall provide, or cause to be provided, performance testing facilities as follows:

- 1. Sampling ports adequate for test methods applicable to this facility,
- 2. Safe sampling platform(s),
- 3. Safe access to sampling platform(s), and
- 4. Utilities for sampling and testing equipment.

L. M. Unless otherwise specified, each performance test shall consist of three separate runs using the applicable test method. Each run shall be conducted for the time and under the conditions specified in the applicable standard. For purposes of determining compliance with an applicable standard, the arithmetic mean of the results of the three runs shall apply.

Emissions testing, as outlined above, shall be performed within 120 days of a process flow change, to verify continued performance at permitted emission limits.

This administrative change was made to correct an error in the formatting of the alphabetic list of conditions.

- 3. Page 16
 - Section VI. titled "Agency Notifications" has been modified as follows:

Permittee shall submit a copy of all compliance and enforcement correspondence as required by this Approval to Construct to:

Compliance <u>Assurance</u> and Enforcement Division EPA Region 6 1445 Ross Avenue (6EN) Dallas, TX 75202

This administrative change was made to correctly identify the complete name of the division.

National Historic Preservation Act (NHPA)

On April 22, 2013, EPA sent a letter to the State Historic Preservation Officer (SHPO) requesting concurrence on EPA findings for KM Liquids Terminal's cultural survey. The SHPO sent a letter with concurrence to the EPA on May 15, 2013.
