Summary of Revisions in Final Permit

I. Summary of the Formal Public Participation Process

The U.S. Environmental Protection Agency, Region 6 (EPA) proposed to issue a Prevention of Significant Deterioration (PSD) permit to Magellan Processing, L.P. (along with its affiliates) on October 25, 2014. The public comment period on the draft permit began on October 25, 2014 and closed on November 24, 2014. EPA announced the public comment period through a public notice published in the *Corpus Christi Caller-Times* on October 25, 2014 and on the Region 6's website. EPA also notified agencies and municipalities on October 25, 2014 in accordance with 40 CFR Part 124.

The Administrative Record for the draft permit was made available at the EPA Region 6's office. EPA also made the draft permit, Statement of Basis and other supporting documentation available on the Region 6's website, and available for viewing at the City of Corpus Christi La Retama Central Library in Corpus Christi, Texas.

EPA's public notice for the draft permit also provided the public with notice of the public hearing. The public notice stated that "Any request for a public hearing must be received by the EPA either by email or mail by November 18, 2014, and must state the nature of the issues proposed to be raised in the hearing...EPA maintains the right to cancel a public hearing if no request for a public hearing is received by November 18, 2014, or the EPA determines that there is not a significant interest. If the public hearing is cancelled, notification of the cancellation will be posted by November 20, 2014 on the EPA's Website <http://yosemite.epa.gov/r6/Apermit.nsf/AirP>. Individuals may also call the EPA at the contact number listed above to determine if the public hearing has been cancelled." EPA did not receive any comments on the draft permit during the comment period, nor any written requests for a public hearing. EPA posted its announcement that there would not be a hearing on November 20, 2014.

II. Revisions in Final Permit

The following is a list of administrative changes for the Magellan Processing, L.P. (along with its affiliates), Condensate Splitter Plant (*PSD-TX-1398-GHG*) *Prevention of Significant Deterioration Permit, Final Permit Conditions*.

Cover Sheet

The cover sheet title "Prevention of Significant Deterioration Permit for Greenhouse Gas Emissions Issued Pursuant to the Requirements at 40 CFR § 52.21" has been modified to state the following:

In accordance with 40 CFR § 124.15(b)(3), this PSD permit becomes effective ~~30 days after the service of notice of this final decision unless review is requested on the permit pursuant to 40 CFR § 124.19~~ immediately upon issuance of this final decision.

This administrative change is made as a result of not receiving any comment during the comment period related to this action.

III. National Historic Preservation Act (NHPA)

On August 13, 2014, EPA sent a letter to the State Historic Preservation Officer (SHPO) requesting concurrence on EPA findings for Magellan's cultural survey. The SHPO sent a letter with concurrence to EPA on August 28, 2014.

IV. Endangered Species Act

On August 13, 2014, EPA received concurrence from the United States Fish and Wildlife Service on its determination that issuance of the permit "*may affect, but is not likely to adversely affect listed species*", the whooping crane.
