The U.S. Environmental Protection Agency (EPA) is providing comments on the subject document pursuant to the National Environmental Policy Act (NEPA), Council on Environmental Quality (CEQ) regulations (40 CFR Parts 1500-1508), and our NEPA review authority under Section 309 of the Clean Air Act.

We provided comments on the Draft Environmental Impact Statement on May 16, 2011. In that letter, we rated the DEIS Environmental Concerns – Insufficient Information, due to our concerns about the applicability California's Drayage Truck Regulations, emissions of sulfur oxide, and voluntary measures to reduce construction emissions.

While the FEIS does not resolve the applicability of the Drayage Truck Regulations, it does state that the Port and project proponent are working with the California Air Resources Board to assess the applicability of the regulations (p.3.2-21). We thank the City of West Sacramento for quantifying emissions of sulfur oxides from the project. Additionally, we are pleased that the project will use the Yolo-Solano Air Quality Management District's best management practices to reduce dust and mobile source emissions.

We encourage the City of West Sacramento to adopt, in its Record of Decision (ROD), all mitigation measures and appropriate best management practices, such as the measures to reduce dust and mobile sources during construction. We also encourage the City to include specific criteria for successful mitigation, consistent with CEQ guidance on mitigation and monitoring issued on January 14, 2011. If any mitigation measures in the FEIS are not adopted, the ROD should provide justification for this decision.
