**Lancaster County**

1. Document progress in developing stakeholder process, including, for example, roles and responsibilities of various stakeholder groups, list of stakeholders, brief summary of stakeholder meetings, stakeholder involvement in development of initial list of control measures, etc.:

Lancaster County officials held its first Early Action Plan organizational meeting on May 22, 2003 at the Lancaster County Administration Building. The meeting was attended by 17 individuals including department heads, citizens, civic organization representatives, and corporate officials.

The initial EAP Organizational Meeting provided the attendees with an explanation of the Early Action Plan and its importance to the County. Attendees who attended the workshop identified 16 areas that can help in improving air quality in Lancaster County.

Lancaster County officials have arranged upcoming meetings with the Chamber of Commerce and area civic groups to educate them about the EAP and to involve these groups and their members in the stakeholder effort.

Additional meetings will be scheduled to more thoroughly involve and coordinate programs and activities to assist in the EAP and improve air quality in Lancaster County.

The goal is to create an EAP team of stakeholders that can assist in the coming months in implementing plans and developing strategies to continue to improve air quality in Lancaster County.

## York County

*York County has developed and approved a County Transportation Plan that forms the basis of the One Cent Sales Tax Referendum Project List to be placed before county voters in November 2003, for approval. The basis of this plan was the Rock Hill-Fort Mill Area Transportation Study (RFATS) Long Range Transportation Plan update process, which began in 2002. This process featured significant public input, as well as the creation of a transportation survey for citizens to complete. The survey and plan process were presented to over 400 citizens, with the survey and public input results placing focus for improvements on intersections and sidewalks. Both the RFATS plan and York County plan recognize this preference and accommodated it through the project selection process in the County Transportation Plan.*

2. Report progress on evaluating and selecting emission reduction measures for the local control strategy.

*While the SCDOT has done preliminary MOBILE runs of the RFATS Long Range Transportation Plan, no other evaluations of measures have been completed as of May 23, 2003.*

Presentations have been made for elected officials in every municipality in York County, as well as business, recreational, development, and citizen groups. *RFATS is in the final adoption stage of the Long Range Transportation Plan and has complied with all SCDOT and FHWA regulations for the transportation planning process.*
