Dear Tribal Leader:

This letter is to invite your participation in the designation process for the new national ambient air quality standard for ozone (the "8-hour" ozone standard). On November 14, 2002, Jeffrey R. Holmstead, Assistant Administrator of the Office of Air and Radiation, issued the enclosed memorandum entitled "Schedule for 8-Hour Ozone Designations and its Effect on Early Action Compacts," which, among other things, describes the new schedule and discusses designations of Indian country. This memo supplements earlier memoranda we provided to tribes in August 2000, "Guidance on 8-hour Ozone Designations for Indian Tribes" and "Boundary Guidance on Air Quality Designations for the 8-hour Ozone NAAQS."

The designation process may affect a number of tribes in Region 9, especially those located in the Phoenix area and in central and southern California. In addition to contacting us for further information (see below) you may find it helpful to contact the National Tribal Environmental Council ([www.ntec.org](http://www.ntec.org), Bill Grantham: telephone 505-242-2175). NTEC has been working closely on this issue with many tribal environmental professionals and with EPA, and will be able to provide supplemental materials developed expressly for tribes on this issue.

The enclosed memorandum asks that you provide EPA with revised or new designation recommendations and documentation for the 8-hour standard by April 15, 2003. EPA will make designations while considering recommendations from tribes and states. Recommendations, although helpful, are not required for EPA to make designations. If EPA determines that a modification to the designation recommendations submitted by a tribe is necessary, EPA will consult with the tribe no later than 120 days prior to promulgating the designations.

We look forward to working with you and your staff to develop designations under the 8-hour ozone standard. If you have any questions, please do not hesitate to contact me. Your air quality staff may wish to contact Doug McDaniel of my staff at 415-947-4106.
