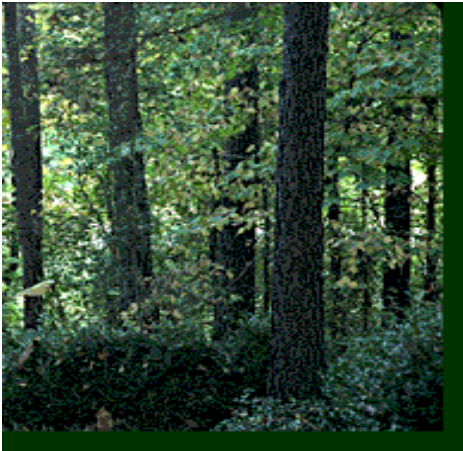

Mississippi and Clear Skies



Highlights of Clear Skies in Mississippi

- Mississippi sources would reduce emissions of SO₂ by 70%, NO_x by 78%, and mercury by 52% by 2020 due to Clear Skies.
- The health benefits in Mississippi would total \$1.6 billion annually (\$280 million under the alternative estimate) and include 200 fewer premature deaths (100 under the alternative estimate) and 400 fewer hospitalizations/emergency room visits each year.
- In addition, Mississippi would receive environmental benefits including reduced nitrogen and mercury deposition and improved visibility. The value of the visibility benefit for Mississippi residents who visit National Parks and Wilderness areas throughout the country would be \$44 million each year by 2020.
- Clear Skies does not significantly impact electricity prices. With or without Clear Skies, electricity prices in the electricity supply region that includes Mississippi are expected to remain below 2000 prices.

Why Clear Skies?

- **Air quality has improved, but serious concerns persist**
 - Mississippi's citizens suffer ill effects from air pollution, including asthma attacks and premature death
- **Electricity generation sector remains a major emissions source**
 - Very cost-effective to control the power sector, relative to other sources
 - Sources are concerned about upcoming complex and burdensome regulations

Advantages of the Clear Skies Approach

- **Guarantees significant nationwide emissions reductions – beginning years before full implementation**
 - Mississippi sources would substantially reduce emissions of SO₂, NO_x, and mercury
 - Delivers dramatic progress towards achievement of critical health and environmental goals
- **Uses proven, market-based flexible approach with incentives for innovation**
 - Recognizes environmental needs as well as industry constraints, allowing industry to better manage its operations and finances while lowering risks to the public
 - Sources are projected to install pollution controls to enable continued reliance on coal
- **Increases certainty across the board for industry, regulators, and consumers**

In developing the timeline of current CAA requirements, it was necessary for EPA to make assumptions about rulemakings that have not been completed or, in some case, not even started. EPA's rulemakings will be conducted through the usual notice-and-comment process, and the conclusions may vary from these assumptions.

Clear Skies Sets a Firm Timeline for Emission Reductions

2004: The NO_x SIP call (summertime NO_x cap in 19 Eastern States + D.C.)

2004

The existing Title IV SO₂ cap-and-trade program provides an incentive and a mechanism to begin reductions upon enactment of Clear Skies years before regulatory action under the current Act.

2008: Clear Skies NO_x Phase I (2.1 million ton annual cap assigned to two Zones with trading programs)

2010: Clear Skies Hg Phase I (26 ton annual cap with a national trading program)

2010

2010: SO₂ Phase I (4.5 million ton annual cap with a national trading program)

2018: Clear Skies Hg Phase II (15 ton annual cap with a national trading program)

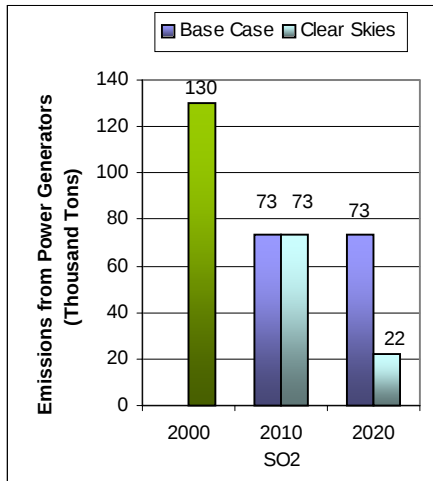
Emissions in Mississippi under Clear Skies

Emissions in Mississippi (2020) would be significantly reduced from 2000 levels:

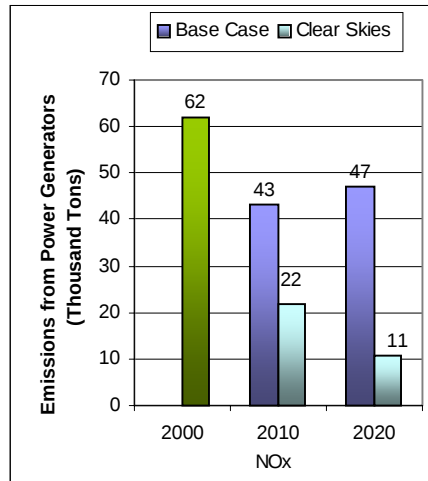
- 83% reduction in SO₂ emissions
- 83% reduction in NO_x emissions
- 68% reduction in mercury emissions

vs. Clear Skies in Mississippi in 2010 and 2020**

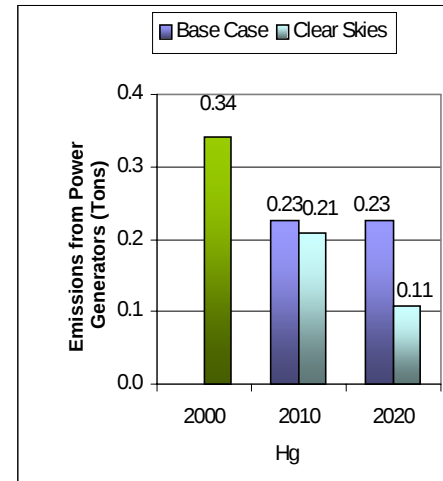
Sulfur dioxide

Clear Skies Health Benefits in Mississippi

Improve Public Health

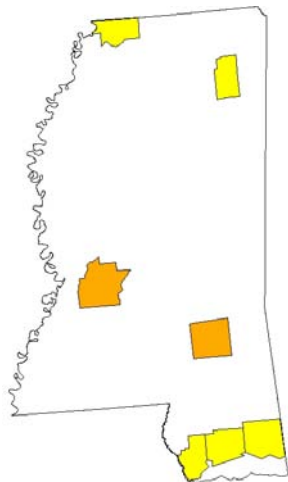
- **Reduced ozone and fine particle exposure** by 2020 would result in public health benefits of:
 - approximately 200 fewer premature deaths each year¹
 - approximately 100 fewer cases of chronic bronchitis each year
 - approximately 300 fewer non-fatal heart attacks each year
 - approximately 400 fewer hospital and emergency room visits each year
 - approximately 21,000 fewer days workers are out sick due to respiratory symptoms each year
 - approximately 4,000 fewer school absences each year
- **Reduced mercury emissions** would reduce exposure to mercury through consumption of contaminated fish, resulting in additional, unquantified benefits for those who eat fish from Mississippi's lakes, streams, and coastal waters.

By 2020, Mississippi would receive approximately \$1.6 billion in annual health benefits from reductions in fine particle and ozone concentrations alone due to Clear Skies.¹

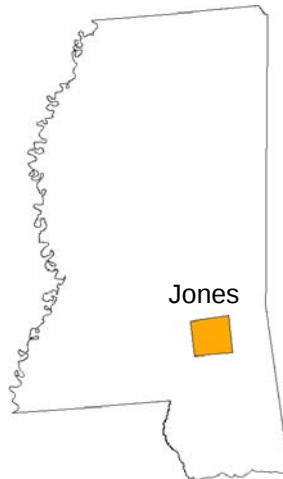
1. An alternative methodology for calculating health-related benefits projects approximately 100 premature deaths prevented and \$280 million in health benefits each year in Mississippi by 2020.

Counties Projected to Remain Out of Attainment with the PM_{2.5} and Ozone Standards in Mississippi¹

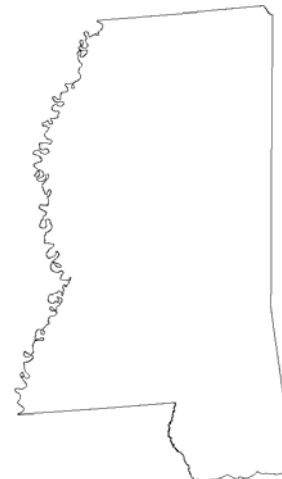
Current Conditions



2010 Base Case



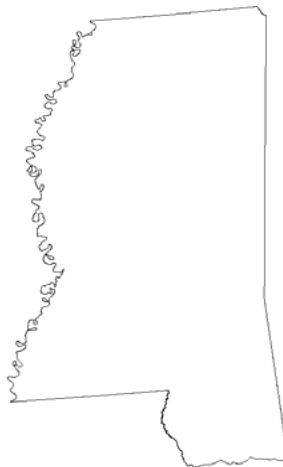
2020 Base Case



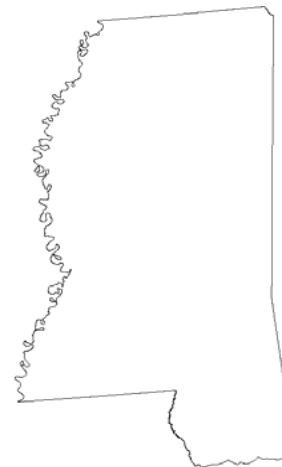
Legend

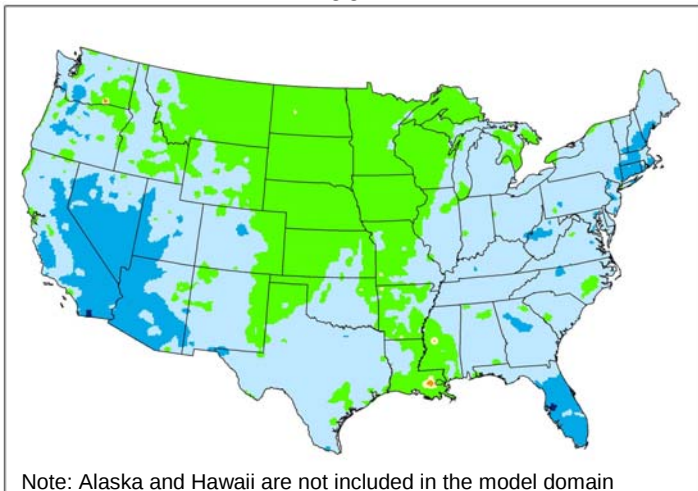
Clear Skies Would Help Mississippi Meet Air Quality Standards

- Currently there are 2 counties exceeding the annual fine particle standards and 5 counties exceeding the 8-hour ozone standard.
 - Both counties are expected to be brought into attainment with the fine particle standards under existing programs by 2020.
 - All of these counties are expected to be brought into attainment with the ozone standard under existing programs.
- **Clear Skies would significantly improve air quality in Mississippi** further and more quickly than what is expected from existing programs.
 - By 2010, Clear Skies would bring the sole remaining non-attainment county (Jones County--population approximately 65,000) into attainment with the annual fine particle standards, earlier than under existing programs.
- In addition, Clear Skies would reduce ozone and fine particle concentrations in counties attaining the standards throughout the state.

2001

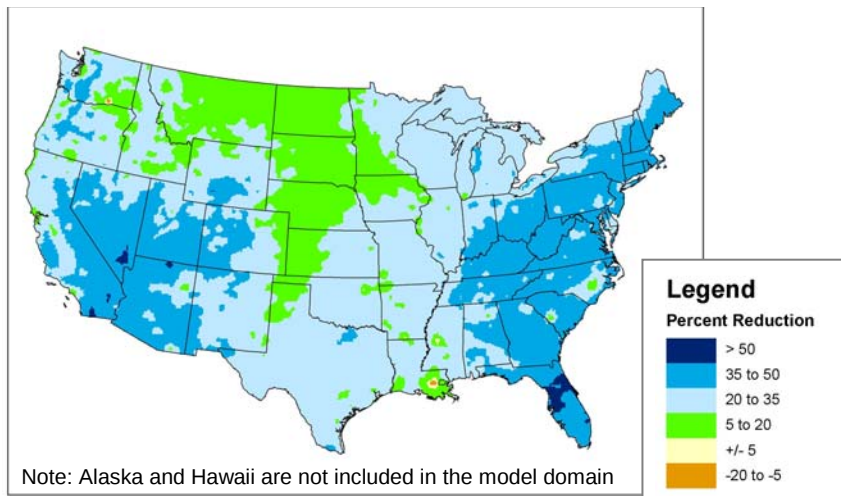


Clear Skies Would Provide Substantial Environmental Benefits in Mississippi

In comparison to existing programs,

- **Visibility would improve** perceptibly.
 - The value of this benefit for Mississippi residents who visit National Parks and Wilderness areas throughout the country would be \$28 million each year by 2020.
- **Sulfur deposition, a primary cause of acid rain, would decrease 15-30%** throughout the state.
- **Nitrogen deposition, a cause of damage in nitrogen-sensitive coastal waters, including the Gulf of Mexico hypoxic zone, would decrease 5-20%** throughout Mississippi.
- **Mercury deposition would decrease up to 15%** in a large portion of the state.*

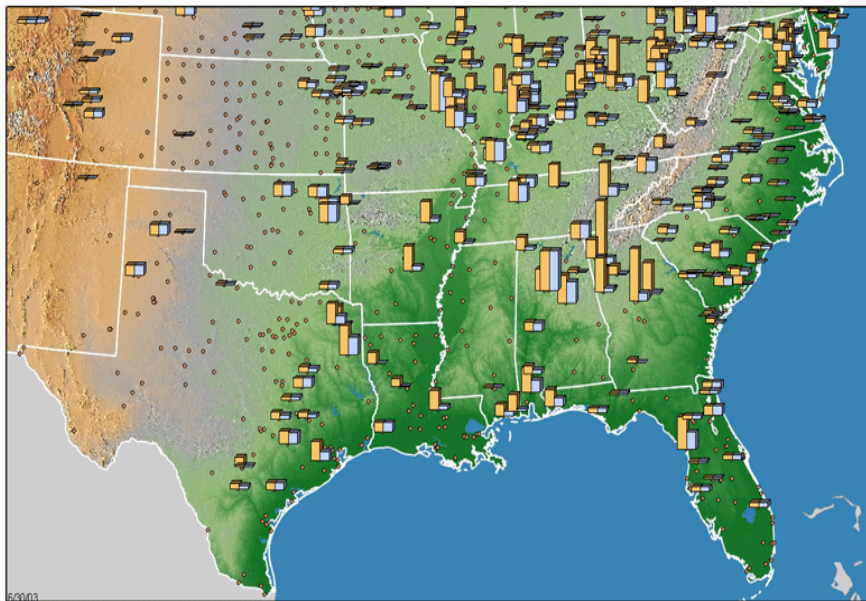
Projected Changes in Nitrogen Deposition

Compared to 2001



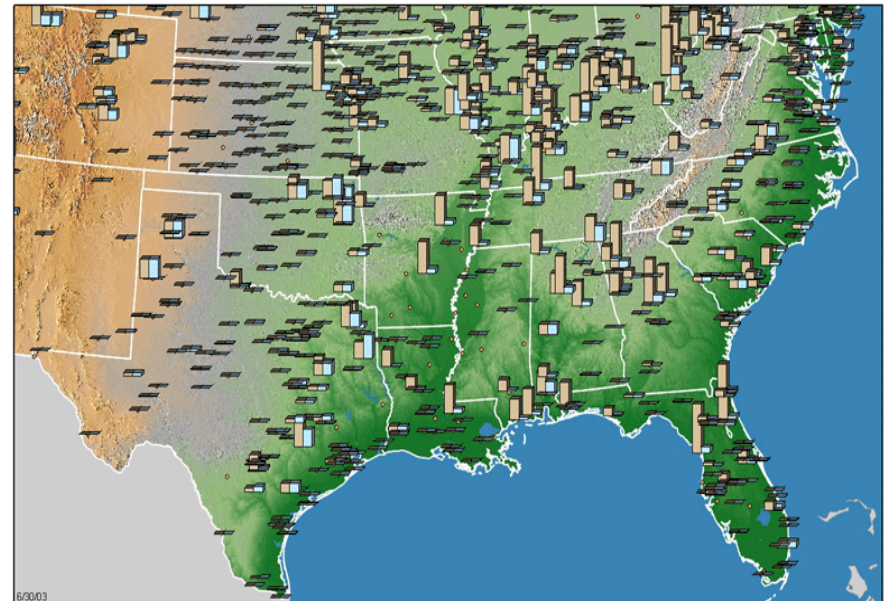
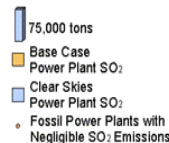

SO₂ and NO_x Emissions Reductions under Clear Skies

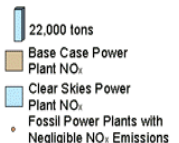
Emissions in Mississippi and surrounding states would decrease considerably. These emission reductions would make it much easier for Mississippi to maintain compliance with the national air quality standards.

South



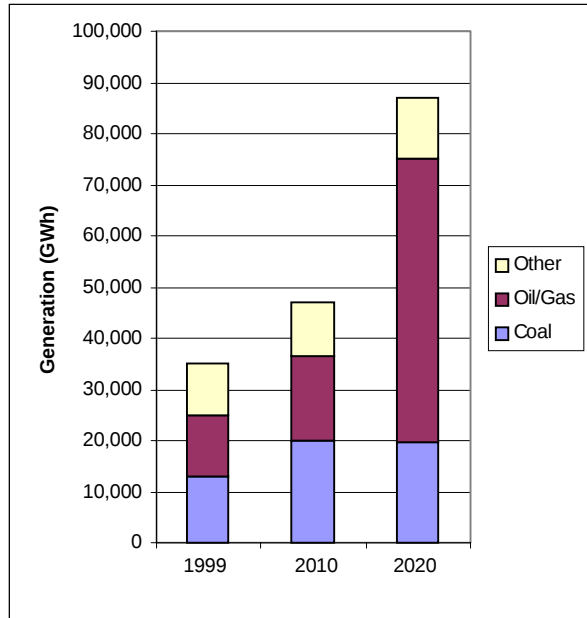
Projected NO_x Emissions from Power Plants

Electricity Generation in Mississippi under Clear Skies

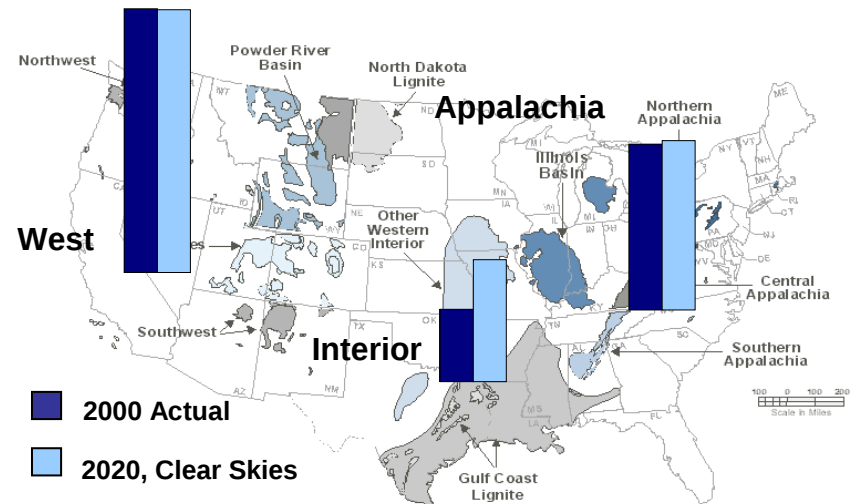
Current and Projected Generation by Fuel Type in Mississippi under Clear Skies (GWh)



- Mississippi's electricity growth is projected to be met by increases in gas-fired and coal-fired generation. Clear Skies does not significantly alter this projection.
 - Electricity from coal-fired generation will increase by 52% from 1999 to 2020.

- Mississippi's sources are projected to reduce their emissions through the installation of emission controls, rather than through a switch from coal to natural gas.
 - In 2010, 50% of Mississippi's coal-fired generation is projected to come from units with advanced SO₂ and/or NO_x control equipment that also substantially reduce mercury emissions; in 2020, the percentage is projected to increase to 100%.
 - No coal-fired units in Mississippi are projected to be removed from operation as a result of Clear Skies.

Emission Controls in Mississippi under Clear Skies

- **Under Clear Skies by 2020...**

- 83% of coal-fired capacity would install SCR or SNCR
- 59% would install scrubbers

- **The major generation companies in Mississippi include:**

- Duke Energy Power Services
- Southern Mississippi Electric Power Association
- Caledonia Power

- **Total coal-fired capacity in Mississippi is projected to be 2,695 MW in 2010**

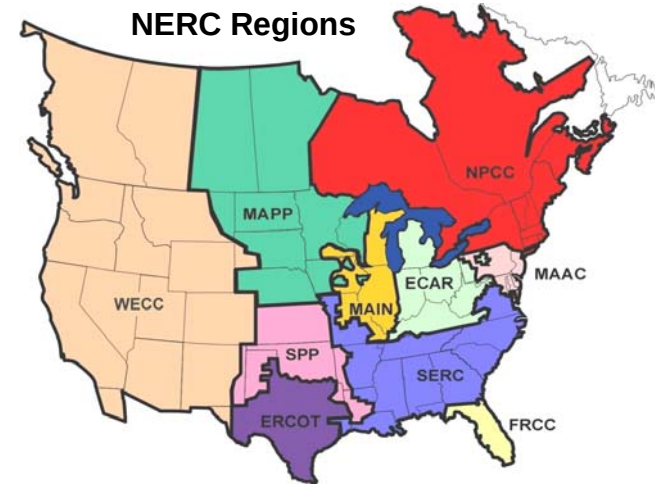

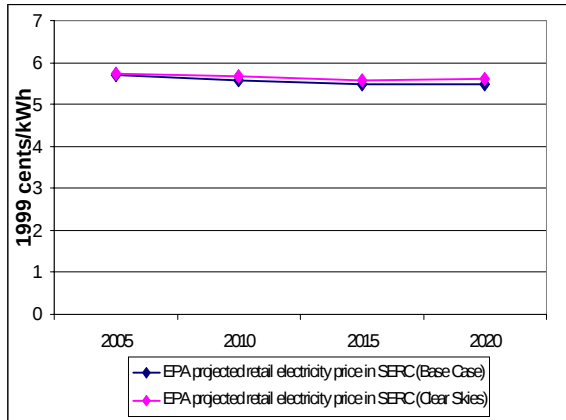

Electricity Prices in Mississippi under Clear Skies

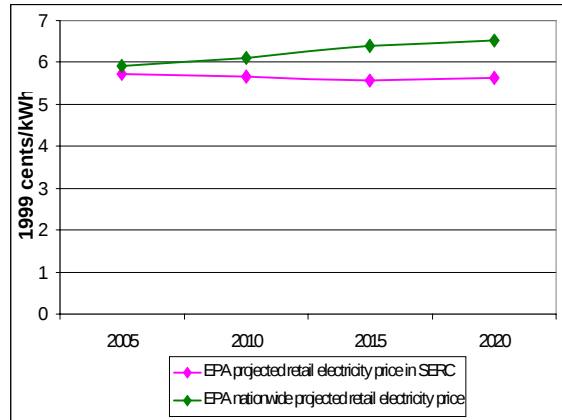
- With or without Clear Skies, retail prices in the North American Electric Reliability Council (NERC) SERC region (the electricity supply region that contains Mississippi) are projected to decrease between 2005 and 2020.
- With Clear Skies, retail prices are projected to be approximately 0.7 – 2.8% higher between 2005 and 2020 than in the absence of the legislation.

In 2000, the average retail electricity price in Mississippi was approximately 5.9 cents/kWh, which was below the average *national* retail price of approximately 6.7 cents/kWh.

Costs and Benefits in Mississippi under Clear Skies

Benefits Outweigh the Costs

- **In Mississippi, Clear Skies is projected to cost approximately \$67 million annually by 2020 while providing health benefits totaling approximately \$1.6 billion annually.**
- **The increases in production costs under Clear Skies represent only a small percentage of total retail electricity sales revenue in Mississippi**
 - Retail electricity sales revenue in Mississippi was almost \$2.7 billion in 1999
 - Adjusting these sales revenues by the same growth rate used for the modeling of costs would result in revenues of almost \$4.2 billion annually in 2020
- **Nationwide, the projected annual costs of Clear Skies (in \$1999) are \$4.3 billion in 2010 and \$6.3 billion in 2020; the nationwide benefits of Clear Skies are expected to be over \$113 billion annually by 2020**
 - An alternate estimate projects annual health benefits totaling \$23 billion

Clear Skies....

- **Guarantees significant emissions reductions – beginning years before full implementation**
- **Uses a proven and flexible market-based approach with incentives for innovation**
- **Increases certainty across the board for industry, regulators, and consumers**

Note: Costs include capital costs, fuel, and other operation and maintenance costs (both fixed and variable) associated with the achievement of the emissions caps in the legislation (for example, the installation and operation of pollution controls). These state-level production costs are estimates; they do not account for the costs associated with the transfer of electricity across regions, nor the costs or savings that could be associated with allowance movement between sources.

Notes on EPA's Analysis

- The information presented in this analysis reflects EPA's modeling of the Clear Skies Act of 2003.
 - EPA has updated this information to reflect modifications:
 - Changes included in the Clear Skies Act of 2003.
 - Revisions to the Base Case to reflect newly promulgated rules at the state and federal level since the initial analysis was undertaken.
 - The Clear Skies modeling results presented include the safety valve feature
 - This analysis compares new programs to a Base Case (Existing Control Programs), which is typical when calculating costs and benefits of Agency rulemakings.
 - The Base Case reflects implementation of current control programs only:
 - Does not include yet-to-be developed regulations such as those to implement the National Ambient Air Quality Standards.
 - The EPA Base Case for power sector modeling includes:
 - Title IV, the NO_x SIP Call, NSR settlements, and state-specific caps in Connecticut, Massachusetts, Missouri, New Hampshire, North Carolina, Texas, and Wisconsin finalized before March 2003.
 - For air quality modeling, the Base Case also includes federal and state control programs, as well as the Tier II, Heavy Duty Diesel, and Non-Road Diesel rules.
