- Create an **electronic mechanism** for capturing & communicating **health & environment information**
- Discuss challenges of **sustainable data collection**
- Designate a **centralized information source** to allow data flow at the local level.
- Create a **mechanism to integrate data** from EHWG initiatives & communicate with other workgroups

Potential Priority Areas: Non Indicators

- Create a publicly-accessible **bilingual air quality center**
- Create a **web site** that cites border **air quality information**
- Designate unofficial **binational common sister-city air basins** for measurement of air pollution

- Establish an Environmental Health Indicators Workgroup (**BITF established**)
- Update Border Yellow Pages (**HRSA E-Group**)

EHWG/BITF Joint Meeting

“Border Indicators: Moving Forward”

El Paso, TX, May 4-5, 2004

- Fund projects to be supported near-term to “jump start” the effort
