### PRIA 3 Status October 1, 2012 – June 10, 2013

    - 58.3% of RD PRIA 3 completions occurred before Pre-decisional Determination Due Date;
    - 30.7% of RD PRIA 3 completions occurred between Pre-decisional Determination and PRIA Due Dates;
    - 10% of RD PRIA 3 completions occurred on the PRIA Due Date;
    - 1 RD PRIA 3 completion occurred after the PRIA Due Date under the 2-day label review process and was completed in 1 day.
  - Performance to date: AD
    - 32.8% of AD PRIA 3 completions occurred before Pre-decisional Determination Due Date;
    - 53.7% of AD PRIA 3 completions occurred between Pre-decisional Determination and PRIA Due Dates;
