GOVERNMENT GRANTS

Inter-tribal Technical Assistance Energy Awards (\$7 million). The Department of Energy is funding inter-tribal technical assistance energy providers' networks for Indian tribes. The Office of Indian Energy is seeking applications for this pilot program from inter-tribal organizations that will use internal energy experts to provide technical assistance on energy use to their tribal members. Awards are expected to range from \$300,000 to \$1,000,000, and will be for three to five years. Pre-Disaster and Flood Mitigation Assistance Grants (\$90 million; \$199 million). For the pre-disaster program, the Federal Emergency Management Agency (FEMA) is funding hazard mitigation projects that reduce risk to people and property. For the flood mitigation program, FEMA is funding efforts to reduce or eliminate risk of flood damage to buildings insured under the National Flood Insurance Program.

More Classes. The Institute for Tribal Environmental Professionals (ITEP) is also offering a series of classes on air quality. Here's what's coming up.

- **Fundamentals of Air Monitoring**, Tuesday, April 5, 2016, to Thursday, April 7, 2016, Las Vegas, Nev. This course provides an understanding of how to develop and conduct an air-monitoring project. Designed as an overview of the topic, the course will focus on criteria for air pollutants, as well as monitoring requirements for those seeking National Ambient Air Quality Standards (NAAQS) designations from their monitoring projects. It will also include information about meteorological monitoring and air toxics. Air-monitoring equipment will be available for hands-on activities.
- **GIS for Air Quality**, Tuesday, April 26, 2016, to Thursday, April 28, 2016, Las Vegas, Nev. This course will provide tribal environmental professionals with the skills to map and interpret air quality data using GIS (Geographic Information System) software. Participants will learn to integrate data (including Access and Excel file formats) into a GIS project. Prior GIS experience is not required; however, basic computer skills are necessary.

FDA Says Stay Away From 'Bentonite Me Baby.' The U.S. Food and Drug Administration is warning consumers not to use "Bentonite Me Baby" by Alikay Naturals because of a potential lead-poisoning risk. Lab tests have showed an elevated level of lead in this product, according to the FDA. Bentonite Me Baby is marketed as medicinal clay and its labeling says that it can be ingested and applied to hair and skin. The FDA recommends that anyone who has used this product should consult a health care professional.
