## **On-Site Mentoring Available**

The <u>Institute for Tribal Environmental Professionals</u> (ITEP) is offering seven on-site mentoring opportunities for tribes to develop or refine solid waste programs.

In 2015, projects included the following:

- The Havasupai Tribe in the Grand Canyon worked with a composting technical expert to develop a composting program, helping the tribe to divert a significant amount of solid waste.
- The San Manuel Band of Mission Indians collaborated with the Shakopee Mdewakanton Sioux Community to learn about new source-reduction and waste-diversion strategies to develop a Zero Waste plan. (continued)

All successful applicants can request peer-to-peer consultation with another tribe, or they can request a visit from a subject matter expert to their tribe. ITEP will reimburse all travel expenses for a visit to another tribe.

**DEADLINE:** Applications will be reviewed as they come in, so applications submitted as soon as possible would increase chances of applicants being selected for the program.
