I said I had never been confused with a nun before, but it made me reflect on the need to be conscious of what each individual brings to the meeting and how my actions affect their ability to participate.”

Senator Boxer Grant Newsletter – Support to the National Tribal Water Council

The U.S. Environmental Protection Agency’s Office of Water (OW) is requesting applications to conduct, coordinate, and promote the acceleration of research, studies, training, and demonstration projects that will support the participation of the National Tribal Water Council (NTWC or “Council”) and tribes to prevent, reduce, and eliminate pollution to waters, and protect drinking water in Indian country. The successful applicant will maintain, support, and facilitate the operations of the NTWC, and assist in developing and completing products in coordination with the NTWC on the quality of tribal water resources, watersheds, drinking water, and wastewater sanitation from tribal perspectives.

U.S. EPA Region 9 – Vector Borne Diseases Workshop

The U.S. EPA will be conducting an in-depth workshop on developing, funding, and implementing Integrated Pest Management Plans and Vector-Borne Disease prevention programs. Tribal environmental and public health professionals in high-risk areas for the Zika Virus (see risk map in the flyer) are highly encouraged to attend. Participants will develop specific capacities around:

- Knowledge of Vector Borne diseases (risk assessment, transmission, and spread) and the federal agencies working on these health crises
- Developing and implementing outreach and education programs and solid-waste clean-up projects to prevent the spread of Zika and Rocky Mountain Spotted Fever
- Using GAP funding to build capacity in Vector Control Management
