## Dear Mr. Bardo:

Enclosed please find the subject document regarding full-scale implementation of thermally enhanced soil vapor extraction (T-SVE) of the unsaturated zone in the Former Chlorobenzene Process Area (CPA) at Solutia Inc.'s W. G. Krummrich Plant, Sauget, IL. (A similar document for enhanced aerobic bioremediation (EABR) of the saturated zone is being submitted separately.)

The "Final Decision" dated February 26, 2008, for the W. G. Krummrich Plant requires in part that, in a "Construction Completion Report," "a registered professional engineer and the Solutia Project Manager shall certify that the remedy at the Former Chlorobenzene Process Area has been conducted in accordance with the U.S. EPA-approved final design and specifications, to the best of their knowledge ...." The enclosed document and that for EABR are intended to be those "final designs and specifications" to serve as the basis for that certification for the Former Chlorobenzene Process Area.

Per the "Semiannual Progress Report" submitted on September 15, 2011, CPA remedy installation was projected to be completed, and remedy operation begun, in late January 2012 and a Construction Completion Report submitted in mid-March 2012. Those dates were based on proposals / estimates; fabrication / installation contracts have since been executed, and the above dates are now projected to be early March and mid-April, respectively, as reflected in the enclosed document. Well drilling and other field work is now under way; Solutia will advise US EPA of further schedule changes, if any, as soon as possible.
