6(d) REASONS FOR CHANGE IN BURDEN

This ICR is a description of the total respondent burden for all information collection requirements covered in this ICR. The total respondent burden has changed from the previous ICR for a number of reasons. In developing burden estimates for this ICR, EPA conducted consultations with members of the regulated community who provided revised burden estimates for each information collection requirement in this ICR. EPA also revised its respondent universe based on updated RCRIS data. In addition, EPA revised the labor rates for the regulated community. Capital and O&M costs were also included.

While the RCRA program and regulations pertaining to the Part B requirements and the information collection activities undertaken by the respondents have not changed, EPA's estimates of the associated reporting and recordkeeping burden (in hours) per respondent has decreased and the estimates associated with total cost (including capital and O&M) have decreased. EPA believes that the burden reflects a more comprehensive and, therefore, a more accurate portrait of the existing burden on the regulated community.

6(e) BURDEN STATEMENT

Burden means the total time, effort, or financial resources expended by persons to generate, maintain, retain, or disclose or provide information to or for a Federal agency. This includes the time needed to review instructions; develop, acquire, install, and utilize technology and systems for the purposes of collecting, validating, and verifying information, processing and maintaining information, and disclosing and providing information; adjust the existing ways to comply with any previously applicable instructions and requirements; train personnel to be able to respond to a collection of information; search data sources; complete and review the collection of information; and transmit or otherwise disclose the information. An agency may not conduct or sponsor, and a person is not required to respond to, a collection of information unless it displays a currently valid OMB control number. The OMB control numbers for EPA's regulations are listed in 40 CFR Part 9 and 48 CFR Chapter 15.

Exhibit 7 displays the average respondent burden for the information collection requirements discussed in this ICR.

For demonstrations under §264.90 (i.e., releases from regulated units), the public reporting burden is estimated to be zero hours per year, with a recordkeeping burden of zero hours per year. For demonstrations and exemptions from requirements, the public reporting burden for the information collection requirements is estimated to average 2.4 hours per year, and the recordkeeping burden is estimated to be one hours per respondent per year.

For legal review, no burden is estimated for reporting, while the average recordkeeping burden is estimated to be 100 hours per year. No recordkeeping or reporting burden is estimated for general information requirements at §270.1.

For permit application information required under §270.10(j), the average public reporting burden is estimated to be 10 hours per year, with an average recordkeeping burden of 2.1 hours per year.

For demonstrations submitted under §270.14(a), the average public reporting burden is estimated to be six minutes per year (no recordkeeping burden is anticipated).

For general facility standards, the public reporting burden for the information collection requirements is estimated to average 486 hours per respondent per year. The recordkeeping burden is estimated to be nine hours per respondent per year.

For financial assurance, the public reporting burden for the information collection requirements is estimated to average 19 hours per respondent per year. The recordkeeping burden is estimated to average three hours.

For other Part B requirements, the public reporting burden for the information collection requirements is estimated to average 11.5 hours per respondent per year. The recordkeeping burden is estimated to average .5 hours.

For ground-water protection, the public reporting burden for the information collection requirements is estimated to average 237 hours per respondent per year. The recordkeeping burden is estimated to average 5.4 hours per respondent per year.

For solid waste management units, the public reporting burden for the information collection requirements is estimated to average 10.5 hours per respondent per year. The recordkeeping burden is estimated to average 10.5 hours.

For specific unit requirements in sections 270.15 through 270.26, the public reporting and recordkeeping burdens for the information collection requirements vary according to the type of unit. The total average reporting burden for specific unit requirements is estimated to be 1,737 hours per respondent per year. The recordkeeping burden is estimated to average 7.1 hours per respondent per year.

For schedules of compliance, the average public reporting burden is estimated to be 12 minutes per respondent per year. The recordkeeping burden is estimated to average 30 minutes per respondent per year.

For permit modifications, the average public reporting burden is estimated to be 2.4 hours per respondent per year. The recordkeeping burden is estimated to average 12 minutes per respondent per year.

For renewal of permits, the average public reporting burden is estimated to be close to one hour per respondent per year. The recordkeeping burden is estimated to average zero hours per respondent per year.

For special forms of permits, the average public reporting burden is estimated to be 99 hours per respondent per year. The recordkeeping burden is estimated to average one hour per respondent per year.

For interim status, the public reporting burden for the information collection requirements is estimated to average zero hours per respondent per year. The recordkeeping burden is estimated to average zero hours.
