Attached is the information you requested regarding available treatment capacity at Centralized Waste Treatment facilities. This information was collected in the 1991 Waste Treatment Industry Questionnaire by the Office of Water and represents 1989 data. Names and addresses of facilities are also listed.

All of the facilities included have received a final or interim RCRA Permit. None of the information provided pertains to waste which is underground injected. Some facilities did not supply the capacity information requested due to complex operations. Therefore, two totals are presented. One total represents the actual values reported. The second total is scaled-up to included facilities which did not submit data. Below are listed the overall totals:
