The Office of Management and Budget has decided that printers and users of the manifest need not include the "burden disclosure statement" on the manifest if to do so places an additional burden on them. OMB encourages States that have already incorporated the statement to retain it, and encourages those who have not yet incorporated it to add it at a future date. However, the decision regarding whether or not to add the statement is entirely up to the State using the form. Thus, this checklist is optional.
