The Council of State Governments

The Council of State Governments is a national, non-partisan service organization of the 50 states — created, supported, funded and directed by them. The states established the Council in 1933 to improve the state governments and strengthen the state role in the federal system. The Council's members are all elected, appointed and career officials of state governments. The Council has offices in Lexington (headquarters), New York, Atlanta, Chicago, San Francisco, and Washington.

The Council is the nation's only non-profit agency dedicated to serving all branches of state government in all the states and territories. The Council has nurtured new state roles for over 50 years by bringing state leaders together to share ideas, innovations, and solutions. The Council publishes many volumes concerned with state government, including *Suggested State Legislation*, *Innovations Reports*, *The Book of the States*, *State Government News*, and *The Journal of State Government*. The Council regularly conducts meetings of such state legislative groups as the Western Legislative Conference, the Eastern Regional Conference, the Southern Legislative Conference and the Midwestern Legislative Conference. Meetings of regional groups of Governors and Attorneys General are also regularly conducted, as well as national and regional meetings of other elected and appointed state officials from all parts of state government. The Council has 47 different organizations of state officials associated with it, including the National Conference of Lieutenant Governors, the National Association of State Treasurers, and the National Association of State Personnel Executives.

Centers for Health and Environment

The Council established the Centers for Health and Environment, consisting of research programs for health, for environment, and for occupational licensure, to assist state leaders in developing and improving public policies in these subject areas. Recently, the Council has also charged the Centers with identifying new issues in science and technology that will affect the states. A national task force of state legislators, and elected and appointed executive branch officials from all regions of the nation guides the efforts of each of the Centers.

Focusing on state program and policy options, the Centers help states to share information, resources and ideas; prepare model state programs and suggested laws; host working sessions among state, public and private sector leaders to develop and recommend joint solutions to common problems; research issues identified by its members; offer states a central referral service; and identify and articulate key state problems and solutions. In addition to these services, the Centers inform state policy makers through publications on state policy initiatives, including reports, briefs, and survey data; train and develop state officials on issues and policies; and hold timely regional and national forums on problems facing state officials.
