We need to "keep the finger on the pulse" to watch what is going on. Ongoing ecosystem monitoring with the penalties would be a highest priority. Help identify threats, assess restoration success.
NGO	Bring in other bodies (GOM Fisheries Council?) would really help public buy-in.
General Public	Need an dedicated agency/group/clearinghouse to overseee the big picture. Individual agencies tend to not recognize the big picture needs.
General Public	Number 1 issue is habitat loss. Destroyed habitat kills fish. Supported Rigs-to-Reefs program and feels there is a knee-jerk reaction since the oil spill (Idle Iron) has forced companies to pull them down because they can't get the permits fast enough. We need access to policymakers to abate habitat loss that is going on. Federal policy is killing the Rigs-to-Reef program.

General Public	Number 2 issue is getting better information and science. "What was it like before this happened?" Harte Research Institute and UT provide great return on the dollar. The Gulf Council is mostly left out and needs to be included.
