In reviewing the submitted report on the field test of OLE (WPC-001) I found references in the correspondence from IIRB to two "Sponsor letters" which I cannot find. The approval letter from IIRB dated 10 July 07 (p. 139) cites a Sponsor letter of 4 July 07, and the approval letter from IIRB dated 13 July 07 (p. 158) cites a Sponsor letter of 10 July 07.

Have I overlooked these letters? If so, please tell me where they appear. If they were not submitted, please send me electronic images of both letters--as well as of any other correspondence between the sponsor and the IIRB--as soon as possible, and follow up with a hard copy submission, in PR Notice 86-5 format, identified as a supplement to the study report (MRID 47217601).

In addition, please clarify which of the four approved consent documents was signed by each participating subject, and when. A tabular presentation something like this would be ideal:

Dear John,

I am glad to respond to your queries. First, regarding the Sponsor Letters: those are within the correspondence appendix (#11). The letter of 4 July 07 is on page 219. The letter identified by IIRB as being of '10 July 07' is one that I in fact dated '9 July 07', and it is the second entry in that correspondence record, beginning on page 220, concluding mid-way on page 221. I can see why IIRB's specific designation of that correspondence as Sponsor Letters (plus their date inconsistency) made it more cryptic.

Second, the attached table in pdf gives the history of consenting and participation for each subject. Only the ICD versions listed in the table were employed (signed). In compiling the information, we noted that for subject #60, we have consenting on the 12th, but participation beginning on the 10th. We do not believe that that subject was consented late, but rather that she inadvertently consented anew during a visit to the lab on the 12th, and that that form was then retained rather than her signed form from the 10th.
