### Funding Announcement #1: Midwest Clean Diesel Initiative Announces 2007 MCDI Request for Proposals

On Wednesday, July 18, 2007, U.S. EPA Region 5 and the Midwest Clean Diesel Initiative announced the availability of up to \$300,000 in Midwest Clean Diesel Initiative funds for 2007. These funds are available for States, local governments, territories, Indian Tribes, possessions of the U.S. (like Puerto Rico, etc.), international organizations, public and private universities and colleges, hospitals, laboratories, and other public and private nonprofit institutions. EPA Region 5 envisions funding approximately 1-3 cooperative agreements under this announcement ranging from \$75,000 to \$300,000.

# Funding Announcement #2: Ohio Announces \$20 Million Diesel Emissions Reduction Grant Program

The Ohio EPA annouced the Diesel Emission Reduction and Transit Capital Grant Programs. Look for further information as details become available. Below is the legislative language:

Substitute HB 119 (HB 245)

- -Each fiscal year or as soon as possible, the Ohio Director of Budget and Management will (1) transfer \$9,817,105 in cash in fiscal year 2008 and \$10,057,814 in cash in fiscal year 2009 from the Highway Operating Fund to the Diesel Emissions Grant Fund and, (2) transfer \$5,000,000 in each fiscal year from the Highway Operating Fund to the Transit Capital Fund. The amounts transferred will be appropriated.
- -The transfer to the Diesel Emissions Grant Fund should be used for the administration and oversight of the Diesel Emissions Reduction Grant Program within the Department of Development. In addition, Diesel Emissions Reduction Grant Program funds also may be used to fund projects involving the purchase or use of hybrid and alternative fuel vehicles that are allowed under guidance developed by the Federal Highway Administration for the Congestion Mitigation and Air Quality (CMAQ) Program. The Director of Development, in consultation with the Director of the Ohio Environmental Protection Agency, should develop guidance for distribution of the funds from the Diesel Emissions Grant Fund. The guidance should include a method for prioritization of projects, acceptable technologies, and procedures for awarding grants and loans.
- -The transfer to the Transit Capital Fund should be used to supplement the capital portion of the Ohio Public Transportation Grant Program within the Department of Transportation.
- -These cash transfers represent CMAQ program moneys within the Department of Transportation for use by the Diesel Emissions Reduction Grant Program by the Department of Development and for use by the Ohio Public Transportation Grant Program by the Ohio Department of Transportation. These allocations should not reduce the amount of such moneys designated for metropolitan planning organizations.

#### Funding Announcement #3: Minnesota Pollution Control Agency Announces \$1.2 Million in State Funds for Diesel

MPCA has issued a request for proposals for the \$1.2M in state diesel funds. There is currently no closing date on the RFP, but applicants are reminded to check the MPCA web site for updates. ## **EPA Publishes Transportation Conformity SmartWay SIP Guidance**

Late last month, U.S. EPA announced the publication of SIP guidance that describes how to quantify and use reductions in nitrogen oxides (NOx) that result when trucks are outfitted with two specific SmartWay fuel-efficient technologies: trailer aerodynamic kits, and low-rolling resistance tires. U.S. EPA wants to encourage the adoption of SmartWay projects as a cost-effective way to achieve NOx reductions needed for state air quality plans and transportation conformity determinations. NOx reductions calculated using this guidance are then able to be counted toward meeting ozone or particulate matter air quality standards.

As air quality standards tighten, areas will need to look to more varied ways of reducing emissions to achieve or remain in attainment. Getting local shippers and carriers involved in the SmartWay Transport Partnership is a great way to get these reductions.
