On behalf of the Local Government Advisory Committee (LGAC), I am writing to commend EPA's work in supporting the network of Environmental Finance Centers (EFCs). At our LGAC meeting in Sun Valley, Idaho, September 18-19, 2007, Mr. Bill Jarocki, Director of the Environmental Finance Center, at Boise State University, demonstrated the many financial tools of the EFCs. He also led a field trip for the LGAC to gain a better understanding of the unique challenges of small communities and the use of financial tools to help meet these challenges.

One of these computer-based tools, is the *Directory of Watershed Resources* (<http://efc.boisestate.edu/watershed>), a comprehensive searchable database of over 1,100 sources of federal, state, local and private foundation funding and other services. The LGAC believes it is especially useful because it serves as a 'one-stop-shop' for communities in seeking funding and other resources for community projects.

The Directory currently contains information from EPA Region 1 states and the states of Missouri (Region 7) and Arkansas (Region 6). The LGAC strongly recommends that EPA consider expanding this database to add all states because of its value to aid states and local governments in meeting their goals for a sustainable, clean, and safe environment.

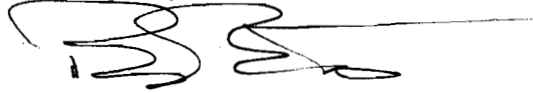
