The protocol and consent form of this protocol fundmentally matches that you are just now considering for EMD-003. Only the sponsor is different, and the test materials are cosmetically improved deet-based formulations. Only lotions are being tested, not sprays, so the dosimetry part of the study is much simplified based on that. The new formulations are intended to give the repellent benefits of deet while minimizing the side-effects.

I have attached the ICF for your consideration, along with the set-up form and site questionnaire. I am finalizing the protocol now.

The second sponsor I have mentioned to you and Kim seems to be missing the boat.... That is probably good news for both of us.
