Initial Protocol Review Milestones

- Jan 08 GPL submits protocol packages to IIRB and CDPR
- 22 Jan 08 IIRB approves protocol, consent form, recruiting flyer, and recruiting scripts
- 25 Feb 08 Approved proposal submitted to EPA
- 10 Mar 08 EPA Science & Ethics Review of proposal
 - 9 Apr 08 HSRB Discussion of proposal
- 11 Apr 08 CDPR Review calls for revisions of protocol and consent form
- 25 Jun 08 HSRB final report of April meeting



Protocol Revision Milestones

- 21 Jan 09 IIRB extends approval for another year
- 27 Jan 09 GPL submits revised proposal to CDPR
- 19 Feb 09 CDPR grants provisional approval, but calls for more changes
- 26 Feb 09 GPL submits further revised proposal to IIRB
- 16 Mar 09 IIRB approves Revised protocol, Consent Form, Recruiting Flyer, and Recruiting Scripts
- 17 Apr 09 CDPR grants final approval



Recruiting/Enrollment Milestones

- 24 Apr 09 Start of subject recruitment through janitorial services
- 5 May 09 IIRB approves Protocol, Amendments 1 & 2, Revised Consent Form, Flyer, and Recruiting Scripts
- 25 Jun 09 IIRB approves Amendment 3 to allow enrollment one-by-one
 - 1 Jul 09 Begin subject enrollment
- 10 Jul 09 IIRB approves Amendment 4 to recruit by newspaper ads
- 13 Jul 09 IIRB OK Newspaper recruiting ads
- 24 Jul 09 Complete subject enrollment



Field Monitoring Milestones

- 27 Jul 09 IIRB approves Amendment 5 to randomize list of all enrolled subjects before assignment to MEs
- 27 Jul 09 Secured Site 1 (office building)
- 10-15 Aug 09 Monitoring at site 1
 - 17 Aug 09 Secured Site 2 (retail)
 - 21 Aug 09 IIRB approves Amendment 7 (New CF)
- 24-29 Aug 09 Monitoring at site 2
 - 8 Sep 09 Secured Site 3 (meeting space)

28 Sep- Monitoring at site 3 3 Oct 09




Analysis, QA Milestones

- 11 Aug 09 GPL begins sample analysis
- 13 Nov 09 GPL completes sample analysis
- 15 Jan 10 GPL submits closeout report to IIRB
- 2 Mar 10 "Last day of data collection"
- 20 May 10 GPL submits Amendment 6 to IIRB
- 24 May 10 IIRB approves Amendment 6
 - 4 Jun 10 GPL submits/IIRB accepts Deviation Report 1
- 28 Jun 10 GPL submits/IIRB accepts Deviation Report 2
- 28 Jun 10 "Study completion"
