Project Synopsis

During this reporting period, the Division of Compliance Assistance (DCA) attended three UST inspections to observe the most common compliance issues associated with operation and maintenance of UST systems. DCA also worked with the Kentucky UST Program and obtained a copy of the proposed Monthly Visible Emission Checklist in development by the program to coincide with a Certified Operator Training Course. Based on these materials, DCA has concluded that a multimedia environmental compliance calendar along with an interactive training presentation would be the best tool for this sector as to not duplicate any materials already in development by the Kentucky UST Program. To date, a skeletal version of the calendar has been drafted which includes environmental compliance topics and pollution prevention/green tips. In the next quarter, DCA will be attending a three day UST training agenda and presentation.

Narrative Discussion

To date, there have not been any significant or unforeseen obstacles to the success of this project. The division will be meeting with the UST branch and other stakeholders such as the Petroleum Marketers Association over the next couple of months to initiate stakeholder review of the compliance calendar and training agenda items as well as begin implementation discussions. In order to allow the division to more effectively target retail gas sectors, the Franklin county geographic area will be targeted for the project. This geographic area has approximately 114 known regulated facilities. In 2008, inspections at these facilities resulted in 162 violations. This averaged to approximately five (5) violations per business, primarily with UST regulations although some wastewater violations were noted.

Given the compliance history with this geographic area and the latest area source rule for Gasoline Dispensing Facilities, the implementation and use of a multimedia environmental compliance calendar will encourage improvements in leak detection and repair as well as overfill and spill prevention, two main areas of non compliance for the sector. The calendar through its green tips and pollution prevention recommendation will also facilitate regulated entities joining KY EXCEL and becoming environmental leaders.
