## Expectations for this Workshop

- Objective Present updated EPA proposals, and results where available, on aspects of MOBILE6; get additional feedback from stakeholders
- Facilitate discussion and obtain input from model users and stakeholders before final decisions are made on approaches

## Expectations for this Workshop

- Comments in response to workshop presentations
  - Want to know IF substantive comments will be coming within 2 weeks (by 10/17/97)
  - Additional time allowed for submitting actual comments (by 10/31/97) on presentations made at this workshop
- Comments should be submitted in writing (by mail or to MOBILE group mailbox: MOBILE@epamail.epa.gov)

#### Comments

- EPA plans to post comments at the OMS Web site (modeling section)
- An open process requires comments to be available to all
- Comments that include proprietary information and/or confidential business information would not be posted; such comments must be clearly labeled

#### MOBILE6 Schedule

- Target release date late in 1998 (beta version next summer)
- Delay in schedule should allow review as outlined below and revisions/updates of all major aspects of model

#### The Review Process

- Expanded participation
  - FACA Modeling Work Group
  - Public workshops (March and October 1997, next spring)
  - Extensive use of Web site and listserver
- Peer review (formal peer review following Agency guidance)
- Stakeholder review (model users & other affected parties)

#### Peer Review

- List of potential peer reviewers has been developed
- Reviewers to be "independent experts"
- Stakeholder review distinct from peer review under current Agency guidance, but considered very important from our perspective

#### Stakeholder Review Procedures

- Objective Ensure that revisions to MOBILE model are reviewed by wide range of parties
- Review procedures
  - Notification of revision or change (listserver, Web site)
  - EPA to provide adequate materials for review
  - Allow 60 days for comments
  - Respond to comments before final decisions or model release
  - Continue to conduct public workshops

#### Stakeholder Review

- Following recommendations of Modeling Work Group
- EPA allowing 60 days for comments on specific materials (proposals, reports, analyses)
- EPA to summarize comments received and provide responses
- Coments to be posted at Web site

#### Stakeholder Review

- Automotive and petroleum industries
- State and local/regional air quality and transportation agencies
- Other Federal agencies
- Environmental organizations
