Frequently Asked Question About Nonroad Emission Factors

Question: Where can the latest nonroad emission factor data be found?

Answer: There are different sources of data on nonroad emission factors, depending on what type of nonroad emission factor data you need. In the near future, this data will be consolidated into a new 5th edition of Volume 2, AP-42, which contains a section for nonroad emission factors. Below is a listing of where to currently find emission factors for various kinds of nonroad sources.
