Dear Mr. Roberts:

Montana is rescinding the letter dated April 30, 2003, confirming the state's previous list of designated geographic areas for ozone. By this action, I confirm that Montana continues to be considered Unclassifiable/Attainment for ozone.

As part of this action, Montana is redefining Part 81.327 geographic area identifications for both 8-hour and 1-hour ozone from areas defined by county boundaries to areas identified by 10,000 meter grid (Grid) intervals using the Universal Transverse Mercator (UTM) spatial referencing system (Attachment 1). Montana understands EPA has until April 15, 2004, to promulgate designations for the 8-hour ozone standard.

Additionally, Montana is redefining Part 81.327 geographic area identifications for carbon monoxide (CO) from areas defined by county boundaries to areas identified by UTM Grids (Attachment 1).
