The Ecological Effects Branch (EEB) has reviewed the request to register MSMA for forest site preparation where loblolly, shortleaf, slash, and longleaf pines are grown. The state of Alabama granted a 24C for this use in 1980 (SLN AL800022).

The 6 core studies required for Section 3 registration (40 CFR, 158.145) were not found in EEB files:

- 71-1 Avian Single Dose Oral LD50 (Mallard or Bobwhite quail)
- 71-2 Avian Dietary LC50 (waterfowl-Mallard)
- 71-2 Avian Dietary LC50 (upland game bird- Bobwhite quail)
- 72-1 Acute Toxicity to Freshwater Fish (Rainbow Trout)
- 72-1 Acute Toxicity to Freshwater Fish (Bluegill Sunfish)
- 72-2 Acute Toxicity to Aquatic Invertebrates

Prior to consideration for Section 3 registration, all studies must be submitted or referenced.

In addition to the 6 core studies, the following tests are required:

- Non-target Plant Tier II, 123-1 Seed Germination, Seedling Emergence, and Vegetative Vigor.
- Non-target Plant Tier II, 123-2 Aquatic Plant Growth for the following species:
 - Lemna gibba (duckweed)
 - Skeketonema costatum (marine diatom)
 - Anabaena flos-aquae (blue-green alga)
 - Selenastrum capricornutum (freshwater green alga)
 - Unspecified species (freshwater diatom)
- Drift data, 201-1.
- Drift data, 201-2.

- 72-3 Acute Estuarine/marine Toxicity Tests:
 - 96 hour estuarine fish LC50
 - 96 hour estuarine shrimp LC50
 - 48 hour mollusk embryo larvae EC50
- Endangered Species Considerations- MSMA will be used as a general vegetation killer (annual and perennial forbs and grasses, perennial woody shrubs, hardwood trees). Because of this broad activity on many diverse plant species, the substantial increase in acres to be treated (beyond the Alabama SLN acres), and the potential for movement off-target, the registrant must show that no threatened/endangered plant species will be adversely affected by this use. The 300 foot buffer zone is unacceptable. Drift statements must be supported by drift data.
