Chevron Chemical Company/Valent U.S.A. Corporation has submitted a request to have a 14-day swimming restriction removed from Diquat Water Weed Killer labels. In support of that request, the registrant has submitted a position paper entitled DIQUAT SWIMMING EXPOSURE RISK ASSESSMENT (Ford, J.E., Chevron Environmental Health Center, December 5, 1988).

Science Analysis and Coordination Branch/Health Effects Division does not oppose the label amendment to remove the 14-day swimming restriction, provided a 24-hour swimming restriction is required (memorandum from Curt Lunchick, 3/23/89; attached). Based on this memorandum, Toxicology Branch I/HED does not object to the removal of the 14-day swimming restriction and supports the proposed 24-hour swimming restriction.
