The registrant has requested a time extension request for the submission of data in response to the Fonofos Registration Standard. The 158.145 Wildlife and Aquatic Organisms' data requirements are the Daphnia Life-Cycle (72.4) and Rainbow Trout Life Cycle (72.4) originally required to be submitted March 31, 1987. However, the registrant cites technical difficulties in conducting the studies and has requested a time extension to April 3, 1987 for the Daphnia study and April 17, 1987 for the Rainbow trout study. Considering that the required and proposed submission dates are too late for time extension considerations, EEB recommends that the PM check their files to determine if the data has been submitted to the Agency.
