Spray Drift Data Requirements

The Malathion Reregistration Task Force has provided the Agency with a notice stating that it will participate in the Spray Drift Task Force as presented in the PR Notice 90-3.

The EPA accepts this notice of participation.

It should be noted that for all spray drift data requirements, there is no waiver of the requirements with the participation in the Spray Drift Task Force. All spray drift data requirements will remain in effect as requested. Time extensions for submission of the data must be requested on a product by product basis. (A company or task force may request several product extensions at one time, but each product must be individually identified.) If the EPA feels that certain spray drift information must be made available to the EPA before the final Spray Drift Task Force report(s), those data requirements [for a particular chemical(s)] will be identified for submission with an accelerated time schedule.
