## 200.0 INTRODUCTION

### 200.1 Use

A 1.00% Sodium Monofluoroacetate (Compound 1080) solution enclosed in a two-pouched rubber vessel which is attached to Velcro bands which hold the pouches in place in the throat regions of sheep or goats subject to predatory attacks by coyotes.

### 200.2 Background Information

See efficacy reviews of 3/21/88, 10/21/88, 3/6/89, 12/1/89, 10/22/90, 4/30/91, and 10/16/91, along with other information in product jacket. The current submission consists of a letter of 11/8/91 to which are appended five copies of a proposed revised technical bulletin which NMDA claims to have changed and corrected in response to EPA's letter of 10/18/91.

## 201.0 DATA SUMMARY

No efficacy data were submitted.

In this latest proposed revised technical bulletin, NMDA has used capital letters rather than numbers for its Use Restrictions. I see nothing wrong with this practice (which makes the outline form of the Use Restrictions section more "correct.")

## 202.0 CONCLUSIONS

Your proposed revised technical bulletin submitted November 8, 1991, is acceptable, although we found the minor errors listed below. Please correct them in your final printed labeling.

1. In last "DO" (page 3), change "hand" to "hands."
2. Delete "inert" from first sentence of first full paragraph on page 6.
3. Delete "inert" from first sentence of first full paragraph under heading "Handling collars and . . . soil" on page 9.
4. Change footnote to "Use Restriction F." to read
