

Although Ciba-Geigy is no longer supporting aquatic non-food uses of SIMAZINE there are other companies that will be supporting the use of SIMAZINE-containing products in aquaria, ornamental ponds and swimming pools.

The Branch believes that the data that will be available on SIMAZINE (from studies required to support agricultural uses of simazine and surface and/or ground water monitoring) by Phase V should allow the Branch to assess the fate and transport of SIMAZINE in the environment. In addition, the terrestrial uses of simazine by far outweigh the remaining aquatic uses supported by other companies. The Branch is not requiring any new study to support these uses.

The data requirements that would be normally imposed for aquatic non-food uses of SIMAZINE are:

- a. Hydrolysis (161-1)
- b. Photodegradation in Water (161-2)

- c. Anaerobic Aquatic Metabolism (162-3)
- d. Aerobic Aquatic Metabolism (162-4)
- c. Mobility in Soil (163-1) (A sediment must be included)
- d. Aquatic (sediment) field dissipation
- e. Bioaccumulation in Fish

The Branch has acceptable studies for the 161-1, 162-3, and 165-4. A new 161-2 and supplemental information for the 163-1 have been recently submitted by Ciba-Geigy and are currently under review. The Branch has also supplemental information on the dissipation of SIMAZINE in ponds and swimming pools (MRID #s 40614422 and 40614420, respectively).
