In our review of 1/9/85, PP# 4E3058 and PP# 4E3059 (L. Kutney), we said that before a favorable recommendation could be made for this petition, the petitioners should submit the Confidential Statement of Formulation for Banrot® 40WP in order for us to determine whether all inerts in this formulation are cleared under Section 180.1001.

The Confidential Statement of Formulation for Banrot® 40WP, has been given. For a detailed discussion and a description of the formulation, see the Confidential Appendix.

Jack Tourer of the Registration Division has orally stated in a conversation with L. Kutney (10/7/85) that all of the inerts in the Banrot® 40WP formulation were cleared under Section 180.1001(d) and 180.1001(e) of the 40 CFR.

We consider this deficiency resolved, and conclude that the inerts included in the formulation are cleared under Section 180.1001 of the CFR, for the proposed use.

Recommendation

TOX considerations permitting, we now recommend for the proposed tolerances of 0.2 ppm thiophanate-methyl on cabbage, lettuce, eggplant, and tomato.
