The EEB has reviewed the Acephate Registration Standard as well as EEB files and has identified the following generic data requirements as unfulfilled:

70-1 Special Test
- Avian Food Residue and Enzyme Monitoring

The data submitted by the Registrant to satisfy this requirement was found to be "Invalid" to support Reregistration (See Reviews by R. Felthousen dated 6/21/88 and 1/21/93).

If the 70-1 Avian Food Residue and Enzyme Monitoring Study provides data which, when used in risk calculations indicates that levels of concern for birds are exceeded, then EEB will further characterize the risk to birds, discuss the value of additional information including additional monitoring and field studies, and present potential mitigation measures, if appropriate.
