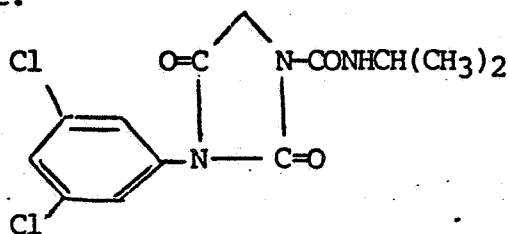
Rhone-Poulenc, Inc. has submitted an application for registration of Iprodione for use on almonds.

No new environmental chemistry data were submitted with the application. Environmental chemistry data have been previously submitted and considered adequate to define the environmental fate of Iprodione for this use.


