EEB agrees with Donald Surprenant's (Springborn Laboratories, Inc., December 20, 1991), comments concerning consistency of our control mortality policy in his letter to Ellen Mihaich of Rhone Poulenc (MRID No. 421693-01). Hence, the study is upgraded to "core", meets the guideline requirements, and no replacement study is needed. The results of this acute study with technical iprodione (100% A.I.) show an LC50 (95% confidence interval) of 0.68 (0.54 and 1.0) mg A.I./L and that iprodione is highly toxic to mysid (Brook, 1973).


