INTRODUCTION

Registration Division has requested NDEB/OREB response to registrant (Mobay Corporation) comments on previous NDEB/OREB review of exposure data on Bayleton (triadimafon) submitted in support of products containing the new fungicide active ingredient, tebuconazole. The previous review is identified as HED-9-0148 dated July 11, 1989: Review of Data on Applicator and Mixer/Loader Exposures to Triadimafon During Ground-Spray Application of Bayleton Fungicide to Wheat. In this review NDEB/OREB made several comments on the exposure study and deferred evaluation of a complete assessment of Bayleton until completion of review of toxicology studies. The registrant had responded specifically to our comments in a letter of August 30, 1989.

CONCLUSIONS/RECOMMENDATIONS

OREB will defer response to the registrant's comments and completion of the exposure assessment until it receives a formal request to do so from the appropriate Toxicology Branch or SACB.
