Regarding Sandoz, Inc.'s request for written confirmation on the adequacy of existing fish and wildlife acute toxicity data for the proposed building perimeter use of Safrotin™ EC Insecticide, please note that these data are sufficient for this use, as was noted in the 2/9/82 meeting with the registrant (memorandum of conference attached). This was previously explained in writing in EEB's 10/1/81 Review (Sections 107.4 and 107.5), an additional copy of which is also attached.

Please note that the Daphnia LC<sub>50</sub> value of 14.27 ppm cited in J. Leitzke's review of 6/15/79 is in error. The value should read 14.27 ppb. The 10/1/81 EEB Review and 2/9/82 Memorandum have also been amended to reflect this correction.
