COMMENT: A SECOND 21-DAY DERMAL STUDY WAS PERFORMED ON METSULFURON METHYL,
AND THIS WAS REVIEWED PREVIOUSLY (TB II MEMO DATED 6/29/89). THE STUDY
WAS CLASSIFIED CORE SUPPLEMENTARY, PENDING SUBMISSION OF DATA FOR CONFIRMATION
OF THE TEST MATERIAL CONCENTRATION/HOMOGENEITY/STABILITY. IN RESPONSE TO
THE REQUEST FOR THESE DATA, INFORMATION ON THE HYDROLYTIC STABILITY OF
METSULFURON METHYL AND ON DOSE PREPARATION WERE SUBMITTED (COVER LETTER
DATED SEPTEMBER 25, 1989).

INDIVIDUAL DOSES WERE PREPARED EACH DAY BEFORE DOSING (WITHIN 30 MINUTES OF
PREPARATION); AN APPROPRIATE AMOUNT OF TEST MATERIAL WAS WEIGHED OUT AND
DISTILLED WATER WAS ADDED TO FORM A PASTE, WHICH WAS THEN TRANSFERRED
DIRECTLY ONTO THE ANIMAL'S BACK.

STABILITY INFORMATION INDICATES THAT THE COMPOUND IS STABLE UNDER VARIOUS
PH'S AND AT TEMPERATURES OF 25° AND 45° C. ALTHOUGH THE PH OF THE TEST
MATERIAL (PASTE) WAS NOT MEASURED DURING THE STUDY, IT IS LIKELY THAT THE
TEST MATERIAL WAS STABLE OVER THE COURSE OF THE EXPOSURE (6 HOURS). THE
DATA ARE ADEQUATE; THE STUDY CAN BE UPGRADED TO CORE MINIMUM.
