

1.0 INTRODUCTION

Chemical Name and Type of Pesticide: paclobutrazol, (2RS, 3RS)-1-(4-chlorophenyl)-4,4-dimethyl-2-(1H-1,2,4-triazol-1-yl)pentan-3-ol, 50% ai, growth regulator.

ICI Americas is requesting some minor changes in its BONZI label as indicated on the attached copy. This is part of an application for registration on ornamentals in greenhouses that was previously reviewed (15 March 1984).

3.0 DISCUSSION OF DATA

No new data submitted.

4.0 RECOMMENDATION

4.1 A previous review (15 March 1984) of the use of BONZI as a plant growth regulator on ornamentals in greenhouses evaluated the required data (hydrolysis, aerobic soil metabolism, and leaching) and found them satisfactory, for the material submitted. Lacking was an aged leaching study, needed to determine the mobility of aged residues (metabolites).

4.2 EAB does not have all the data needed to support the proposed use. An aged leaching study is still lacking. The minor label changes have no effect on the previous review.
