On April 10, 1992, Miles Corp., formally Mobay, submitted a de minimis dietary exposure and risk assessment for tebuconazole on peanuts per an agreement reached in a meeting between Miles, PM Team 21 and Toxicology Branch held March 26, 1992. The information was sent for review on April 16, 1992 to TB-2 and SACB, with a due date of July 5, 1992 for each branch.

This information was requested on behalf of the Toxicology Branch so that they could make a recommendation regarding the issuance of the temporary tolerance and EUP. It is the only pending information not yet reviewed.

It is critical for Miles to obtain a decision concerning the EUP and temporary tolerance as soon as possible so that they will not lose the upcoming growing/testing season.

We are requesting that the data be reviewed in an expeditious manner, by May 15, 1992. If you are unable to meet this date or if this will adversely impact other actions, please contact me.

ATTN: JIM KARIYA - SUSAN LEWIS REQUESTED THAT A COPY OF THIS SUBMISSION BE SENT TO YOU FOR REVIEW AND COMMENT. ENCLOSED IS A COPY OF A DE MINIMIS DIETARY EXPOSURE AND RISK ASSESSMENT FOR TEBUCONAZOLE ON PEANUTS. MILES CORPORATION MET WITH SUSAN, MYSELF, JIM ROWE AND ALBERTO PROTZEL TO DISCUSS THEIR TEMPORARY TOLERANCE PETITION AND EUP FOR THE USE OF TEBUCONAZOLE ON PEANUTS. RD WAS READY TO GRANT THE EUP AND TEMP. TOL., BUT TOX WAS HESITANT DUE TO A 6A2 SUBMISSION THAT CAME IN CONCERNING A MOUSE ONCO STUDY FOR THE PERMANENT TOLERANCE AND SEC 3 REG. TOX REQUESTED HISTORICAL CONTROL DATA AND THEY WANTED TO REVIEW THAT DATA TO ASSURE THAT NO CHANGES WOULD BE NEEDED CONCERNING THE TEMP TOLERANCE BEFORE ISSUANCE. MILES ARGUED THAT THE TIME IT WOULD TAKE TO GET THE DATA IN WOULD CAUSE THEM TO MISS THE USE SEASON FOR THE EUP. TOX AGREED IN THE MEETING WITH MILES THAT THEY WOULD CONSIDER LOOKING AT A DE MINIMIS RISK ASSESSMENT, AND IF FAVORABLE, WOULD AGREE TO THE ISSUANCE OF THE EUP AND TEMP TOL.
