
Manufacturing Process Not Included

In response to the Product chemistry reviews dated September 2 and September 13, 1992 on Sumilary Technical Insecticide, the Technology Sciences Group Inc. on behalf of the Registrant submitted (October 20, 1993) supplementary product chemistry data on Series 61-2 (beginning materials & manufacturing process). The Agency requested additional data on the following topics:

Listing of process equipment, a description of quality control process, information on methods used to remove possible contamination from manufacturing equipment resulting from prior use, information regarding the possibility of post production reactions, information on the possible migration of impurities from packaging materials, information on the source of impurities identified in the CSF, and information on the possible formation of nitrosamines, dioxins, dibenzofurans.
