- Flubendiamide (OP Alternative for some uses)
- Thien carbazonne (Global Review)

FY08 Registration Activity- New Uses

New Uses

- Approved 302 new uses of 77 previously registered conventional active ingredients
- 14 conventional Reduced Risk new uses
- Approved 18 new uses of 5 previously registered biopesticide active ingredients
- Approved 20 new uses of previously registered antimicrobial active ingredients

 - (RD=226, AD=146, BPPD=19)
- Fast Track New Products 407
 - (RD=295, AD=101, BPPD=11)
- Non-fast Track New Products 483
 - (RD=327, AD=110, BPPD=46)

PRIA- Program Performance

Since the start of PRIA (*as of 9/26/08*):

- 7,595 total PRIA/PRIA II submissions
- 6,407 completed
- >99% have been completed by PRIA/PRIA II goal
- 46 "not grant" decisions (<1% of total submissions)
- 1,034 actions with negotiated due dates (14% of total submissions)



PRIA- Program Performance

“Not Grant” decisions:

AD = 10 (total actions=1,407)

BPPD = 22 (total actions=660)

RD = 14 (total actions=5,528)



PRIA- Program Performance

Actions with negotiated due dates:

AD = 291 (total actions=1,407)

BPPD = 207 (total actions=660)

RD = 536 (total actions=5,528)



Pending PRIA/PRIA II Actions

New Active Ingredients

- 12 conventional new active ingredients
- 15 biopesticide new active ingredients
- 5 antimicrobial new active ingredients
- PRIA/PRIA II goal expected to be met in all cases- most new a.i.'s scheduled for completion prior to PRIA/PRIA II goal
