E-Submission Preparation & Quality Checks



- First e-Submission: picolinafen (BAS 700 H) in 2000 (Cyanamid) to PMRA
- First EPA e-Submission: boscalid (BAS 510 F) in 2001 (BASF)
- From 2001-2007, ca. 55 paper/e-Subs completed. Compiled in MRID folder hierarchy format with 'smart' PDFs.
- From 2008 present, ca. 125 paper/e-Subs completed. (MRID folder hierarchy format)

ca. 175 e-subs in XML/PDF format only!

e-Sub Categories

- Currently, e-Subs can <u>only</u> be sent in for...
 - Section 3's
 - EUP's
 - Tolerance petitions
 - Distributor products
- 6(a)(2) 8ee can be handled as well provided it refers to an existing Sec. 3 registration
- Others under consideration (which are also PRIA actions)
 - "Pre-Application" applications
 - Inert Ingredient clearances
- Data call-ins tracked differently and would not interface with current e-Sub system. Changes may be made to accommodate these.

E-Submission Preparation & Quality Checks

BASF 'XML Builder'

- Java-based web application front-end that contains all elements of the E-PRISM data dictionary and interfaces directly to our Documentum study report system (REGY)
 - Allows input of BASF Reg. Doc. #s
 - Extracts metadata from Documentum
 - Pre-selected and enduser-selected E-PRISM data (e.g CBI designation)
 - Handles ALL mandatory fields (e.g PRIA action, contact info, registration type, application type, Me-Too indicator)
 - Compiles final XML file

Quality Check

- XML file is combined with all PDFs and zipped
- Prior to zipping, we run a small Visual Basic app "E-PRISM Validator" to check if any PDFs are duplicated (not allowed)



- Zip file is burned to CD
- CD is checked by re-opening all files
- CD + copy of CD label are sent with request to pin-punch copy of CD label and return as proof of receipt. (If paper sub only, 1st page of cover letter is requested for pin-punching.)

E-Submission Preparation & Quality Checks

- Items checked during proofing documents for an EPA submission
 - No shading
 - No skewed pages
 - Legibility
 - All pages printed
 - No foreign language without translation
 - Signatures on pages 2 and 3
 - Page 2 = Company agent signature
 - Page 3 = Study Director, Sponsor & Submitter signatures
 - If page 3 refers to another page for the Study Director's signature, that page number is correct
 - Paginated with unique number (usually the Reg. Doc #) and page x of y
 - Confidential Appendices must be paginated separately from the study
 - No holes punched in data tables or report. This includes blank spaces from copying
 - Correct table / figure / appendix numbering
