- Metrics of Success Subgroup Due to time constraints, the subgroup did not receive any
 comments from the PPDC meeting October 14. It plans to circulate the draft metrics to
 the PPDC and the Work Group for help with metrics of success before the April 2010
 PPDC meeting.
- <u>Stakeholder Issues Subgroup</u> The subgroup received comments at the PPDC Meeting October 14. It plans to discuss this feedback at a teleconference January 6, 2010. Dave Tamayo and Erica Dahl volunteered to join this subgroup. The subgroup would welcome additional volunteers.
