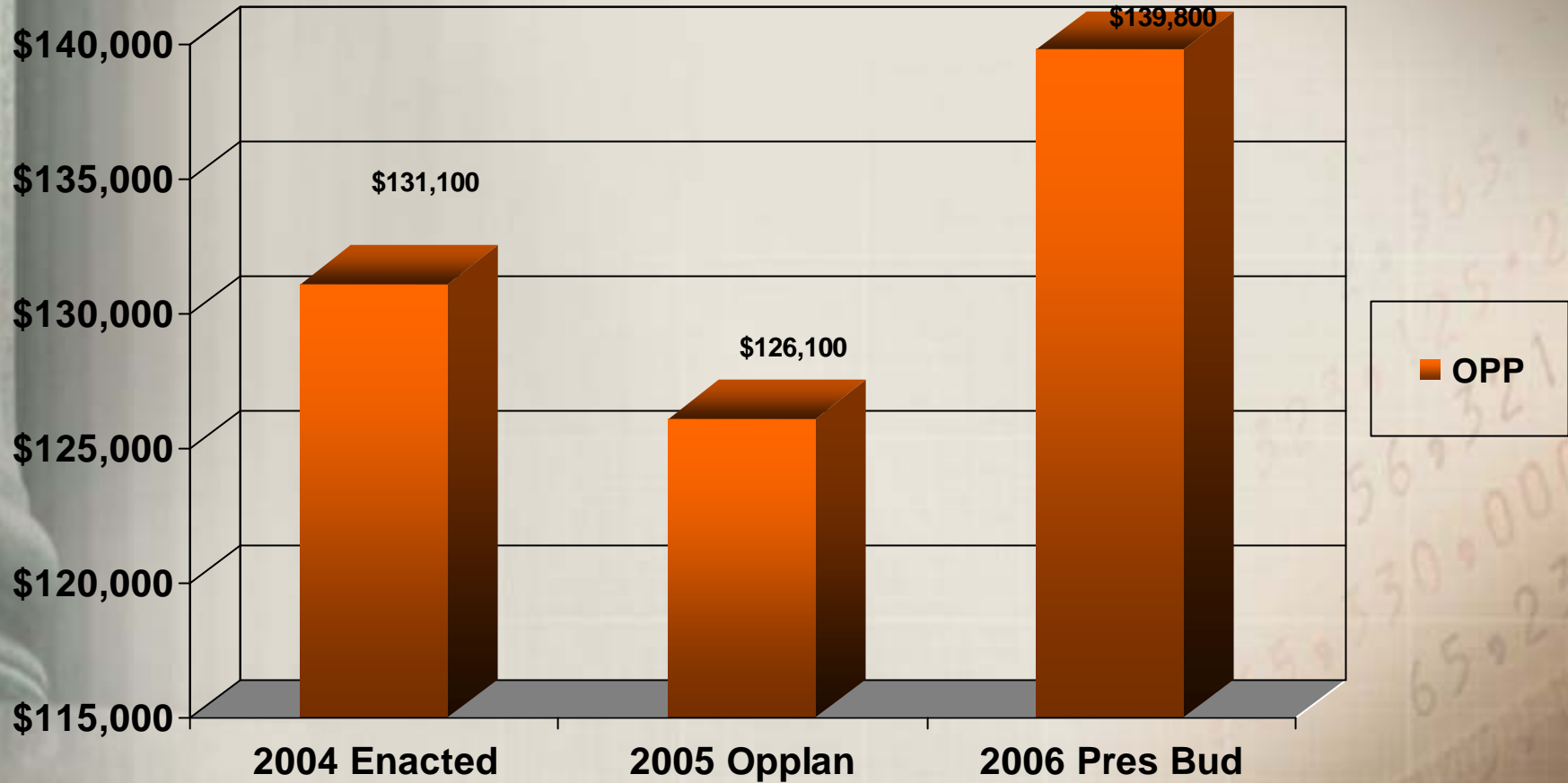

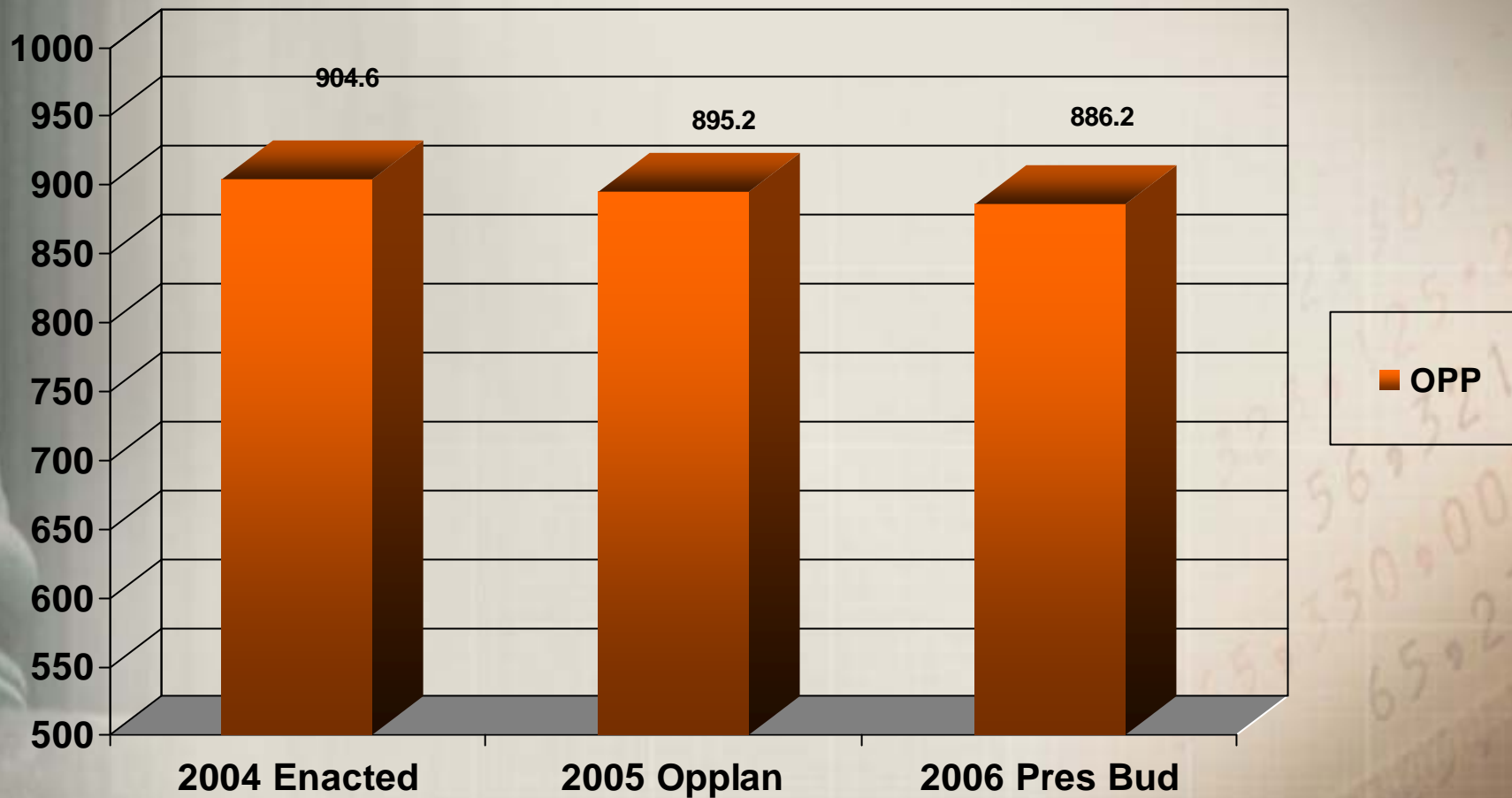

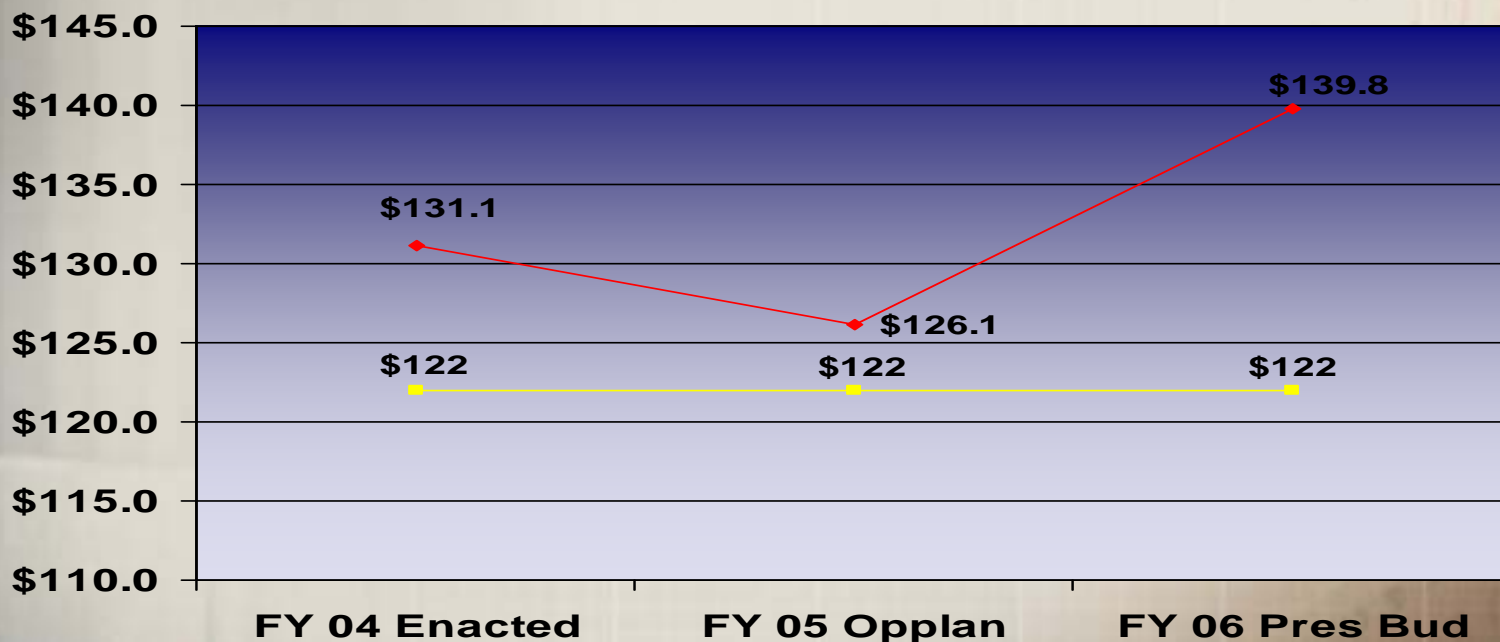

(PRIA) Minimum Appropriation Requirement

2004 Omnibus Language:

***“MINIMUM AMOUNT OF APPROPRIATIONS.** For fiscal years 2004, 2005, and 2006 only, registration service fees may not be assessed for a fiscal year under this section unless the amount of appropriations for salaries, contracts, and expenses for the functions (as in existence in fiscal year 2002) of the Office of Pesticide Programs of the Environmental Protection Agency for the fiscal year (excluding the amount of any fees appropriated for the fiscal year) are equal to or greater than the amount of appropriations for covered functions for fiscal year 2002 (excluding the amount of any fees appropriated for the fiscal year).”*

FY 2002 Appropriation amount as defined in congressional language~\$126M. Resources cannot fall below 97% of the FY 2002 amount.



Note: 97%= \$122 of 2002 Appropriation

Pesticide Tolerance Account (New Account)	\$20M	<ul style="list-style-type: none"> • 04 Omnibus prohibits thru 9/2008 • New Tolerance fee rule will be issued in 2005. • Draft rule due to OMB April 14, 2005 • May be transferred to EPM thru further appropriation
Pre-manufacture Notice Fee (PMN)	<u>\$4M</u> \$50M	<ul style="list-style-type: none"> • Legislation will be proposed to remove cap and to allow for collection of additional PMN Fees. • May be transferred to EPM. • 2005 proposal sent this to Environmental Services Account.

Maintenance Fees	\$27M Estimated Collections	<ul style="list-style-type: none"> • Funds both Tolerance Reassessments and the Reregistration Program. • 04 Omnibus authorized collections at: \$26M/04; \$27M/05; \$27M/06. • Deposited to FIFRA Revolving Fund. • Funds are available to Agency without further appropriation. • Authorized thru 9/2008.
