 - Mesosulfuron-methyl (Reduced Risk)
 - Propoxycarbazone-sodium
 - Spiroxamine
 - Lufenuron (Reduced Risk)
 - Dinotefuran (Reduced Risk/OP Alt.)
 - Penoxsulam (Reduced Risk)
 - Forchlorfenuron
 - Cyazofamid (Reduced Risk)
 - Ipconazole
 - Mepanipyrim (Import tolerances only)
