This is a follow-up to our meeting on April 26, 2000, regarding the USEPA Project XL F006 Sludge Recycling Project proposed for the International Business Machines Corporation (IBM) East Fishkill Facility. The purpose of this letter is to clarify the technical comment raised by a member of the Environmental Management Council regarding the analytical results for cyanide discussed in the presentation. Specifically, the comment raised concerned the difference between the cyanide species presented in the analytical results.

Cyanide compounds typically occur in two forms viz., simple cyanides and complex cyanides. Simple cyanides dissociate into cyanide ions (CN^-) in solution and are easily oxidized. Simple cyanides are also referred to as amenable cyanides. Complex cyanides dissociate into complex ions in which the cyanide molecule is bound to a metal. An example of a complex cyanide ion is $[\text{Fe}(\text{CN})_6]^{4-}$. The sum of amenable cyanides and complex cyanides is known as total cyanides. Analytical methods are available to quantify total cyanides and amenable cyanides in a given sample. The difference between the amount of total cyanide and amenable cyanide represents the amount of complex cyanide.

On behalf of International Business Machines Corporation (IBM) East Fishkill Facility, I would like to take this opportunity to thank the Dutchess County Environmental Management Council (EMC) for providing me with the opportunity to present your members with an overview of our proposed sludge recycling project on April 26, 2000.

The purpose of our presentation to the EMC was to engender the interest of the EMC to be involved in the public involvement process that will be a central component of our XL process.

As outlined in the presentation, the public involvement process can take the form of the EMC or any individual member of the EMC acting as any one of the following:

- **Co-sponsor** - either state, local or tribal governments, or community environmental or other public interest organizations that join the sponsor in proposing the project.
- **Direct Participant** - individuals or groups who choose to work intensively with project sponsors as part of an organized "stakeholder group."
- **Commentors** - individuals that have an interest in the project but choose not to participate directly in an organized group. EPA requires sponsors to provide opportunities for commentors to be heard during the development of an XL Project. Commentors can still affect the design and implementation of the project through comments they make.
- **Members of the General Public** - sponsors must provide the general public with the opportunity to review information about the project.


