## Jeffersontown/Chenoweth Run – XL Pilot Project Stakeholder Meeting Summary

Date: May 9, 2000 (4:00pm @ Jeffersontown Public Library)

The following is a general summary of key discussion topics. It is not intended that every comment or suggestion is necessarily captured herein.

**OVERVIEW OF PERFORMANCE MEASURES** – Mark Sneve, Strand Associates, presented the proposed Performance Measures. Work Group decisions were noted.

Discussion: Efforts should/will be made to coordinate biomonitoring and system sampling whenever possible; biomonitoring chart will be modified to clarify that results are typically <u>less</u> than 1.0 toxicity units.

**PROJECT UPDATE** – Sharon Worley, MSD Project Manager, noted that project is moving along on schedule; Work Group meetings seem to be working effectively; MSD has applied for EMPACT Grant. (Brief overview of the proposed EMPACT Grant is available on request. This Stakeholder Group is asked to help guide the project if awarded.)

Discussion: None.

**OVERVIEW OF PROPOSED REGULATORY REVISIONS** – Sharon Worley gave a brief overview of the proposed revisions (which are available on request). The proposed revisions were submitted to EPA in April 2000. No official comments from EPA at this time.

Discussion: The fact that Significant Non-Compliance status may not be declared for a single late report was discussed.

## OVERVIEW OF WASTEWATER TREATMENT PLANT (WTP) INFORMATION –

Debbie Newton, MSD Regional Manager, noted that the WTP has been successfully passing the biomonitoring test; therefore, completion of the Toxicity Reduction Evaluation is expected soon. She also gave a brief overview of the information regarding the recent upset at the WTP. Vicki Coombs, MSD Area Team Leader, discussed the Facilities Plan for the Jeffersontown WTP. The plan is about 50% completed. A public hearing will be held upon completion this summer. All Stakeholder participants will be invited to attend.

Discussion: There was discussion about possible causes of the WTP upset, but the source of the substance which entered the WTP has not been identified. The schedule for phosphorous removal at the WTP was discussed – it was noted that the draft permit schedules phosphorous removal to begin July 1, 2000.

**WRAP-UP** – The next Work Group meeting is scheduled for May 24; the next Stakeholder meeting is scheduled for August 8. All meetings will be held at 4:00 – 6:00pm at Jeffersontown Public Library unless otherwise indicated.
